The restoration of the Parlor, the Music Practice Room, and the electrical equipment room is virtually complete. Physical rebuilding is done. Furnishings are in. Donated artwork is hung. Insurance and other receipts to date total \$743,987. Expenditures to date total \$688,409. The separate bank account contains \$55,578. Please see our more detailed report attached. Hanover Insurance Co. still owes the church \$40,299. We have one, known bill to be paid, for \$16,671, when repair treatments of the Dunlap paintings are complete. Ultimately, Hanover will pay, and unused funds will be repaid to the Endowment.

## CHURCH ADMINISTRATOR

As Church Administrator, my principal goals are to keep our facilities functioning as well as possible, triaging repair issues, keep the buildings as attractive as possible, and providing clear reporting and management of the church's finances. It is a privilege to work on these tasks and I will share briefly some recent activities/projects: 1) Last month, we were made aware of a water leak downstairs in Macon Outreach; just today, the workers finally discovered where the water was coming from deep within the walls in the basement. From the looks of it, it has been leaking for a while. We are now working on a plan to get it corrected, which is very good news! 2) We have upgraded our magnetic locks on the main doors at the Atrium to bolster security at this entrance. 3) We recently finished the installation of 5 new security cameras in key areas around the perimeter of the church to help us with some security concerns. 4) All the flood lights in the parking lot have been upgraded and four new outdoor flood lights were added in key areas around the building to increase visibility and deter vagrancy. 5) We are in the process of seeking a new tenant for our properties at 770/764 Walnut Street and have engaged the services of a leasing/management agency. 6) We are meeting with several local professionals to help us consider options for the use of the building at 230 New Street. 7) With facilities of this size, we are continually working with our HVAC contractors to keep the heating and cooling units operating well.

The main challenges I face as Church Administrator are keeping the facilities looking nice and operating well. Other than the beautiful renovation we recently completed on the Parlor and the Choir Room, our buildings have experienced a lot of (normal) wear and tear since the big renovation/expansion more than 20 years ago. It is a challenge to stay on top of it and requires the staff to do "triaging" of maintenance/repair needs. We strive to focus our resources/time on the most pressing/critical areas first.

Let's dream together on what steps the church might want to do to "freshen up" our buildings (especially in those areas that have a lot of use) that haven't been updated since the big renovation 20+ years ago.

In January and February, I successfully visited the majority of our shut-ins and homebound members who are currently open to pastoral visits. When visiting, I brought communion, which is always a joy for our members who can't make it to worship in person anymore. January and February featured significant pastoral care needs, as I responded to four deaths in the congregations and many other medical needs (surgeries, emergency room visits, hospitalizations, etc). Ted and I coordinated our first three funerals together, all of which were received well by the families.

Our young adult small group continues to grow (and I will let Spencer detail more about that), and we have welcomed two new members (completely new to Mulberry). We have especially enjoyed our lenten common devotional and the discussions it has afforded us!

Our second Sunday Serve for 3/12 is shaping up well, and the church's giving allowed us to stretch our goal from 125 hygiene kits to 200! We will have a great time putting them together and praying over them before we send them to UMCOR, who will distribute them around the globe.

I am excited about our upcoming Holy Week midday worship services! I have worked with Ted and Zach to craft orders of worship and am excited to serve alongside our five wonderful guest preachers.

And lastly, I am excited about our upcoming G2G trip happening October 20-22, as the church will return to the Hinton Rural Life Center for a weekend trip. We will work all day Saturday and Sunday morning, enjoying a similar experience to Mulberry's past trips to Hinton. Millie and I are working at the present moment to gather initial interest for the trip so that we can let Hinton know our group size. As we get closer to the summer, our staff will make decisions about transportation and other logistics.

A challenge after COVID is constancy. Our strategy in both groups to address this is building personal relationships and engaging activities. We will continue to be involved by recruiting volunteers within the age-level groups on a regular basis, for special events, and activities, or to provide snack suppers or donations for specific trips. One of the major events we have planned is a summer mission trip in Savannah/Tybee Island. The budget and revenue projections are summarized below:

\$4000 - Total cost of Youth Summer Mission Trip (\$400 x 10) or less per person if more than 10 attend

\$2250 - Youth pays \$225 (\$225 x10)

\$500 - Car Wash Fund Raiser? Possibly something else?

\$500 - Church Family Sponsorships (10 X\$50) or more \$

\$750 - Church Budget - The Family Ministries Council will ask the Finance Committee to approve a budget amendment to cover this expense and to approve the youth fundraiser(s).

## **BOARD OF TRUSTEES**

The Trustees met on February 13, in the church conference room.

Hunter and Ted will meet with Fickling and Company to inquire about listing the Walnut Street property. Hunter and Ted will meet with NewTown Macon CEO Josh Rogers about possibly utilizing the New Street property for apartments, which are greatly needed in downtown Macon.


Waverly Golson has done extensive work regarding the Willis Lane properties and gave a detailed report. He has made inquiry to several neighboring property owners, and there is little or no interest by them in acquiring those properties. Waverly has additional inquiries he will make.

The committee voted to approve the transfer of the \$3600 realized from the sale of the Rose Hill cemetery plots into the endowment fund.

Kerri Fickling, Hunter, and others will investigate sources for repair of the tower bell in addition to the current vendor.

Ted raised an additional item of New Business. The Children's Church is experiencing a financial shortfall due to declining enrollment and a shortage of teachers. Following extensive discussion, the Trustees voted to lend the Children's Church \$50,000, with the understanding that Children's Church officials will provide a business plan with projected income and enrollment and a repayment schedule.

On February 28, the Finance Committee sent a request that the Trustees approve the transfer of \$100,265.36 for 2022 and \$9,340.88 from the Endowment to clear deficits from those years. It was noted that these amounts are less than what was projected in the 2022 budget. Voting by email, the trustees approved this transfer request.
