## Re. Opposition to Public Broadcasting Cuts in H.R. 4 - The Rescissions Act of 2025

Dear Senator Murkowski and Senator Sullivan,

We write today to express our opposition to the public broadcasting cuts in H.R. 4, which is currently under consideration in the United States Senate. Given that Alaska is a vast and rural state, public broadcasting is integral for the health, safety, and well-being of Alaskans. In rural areas with limited to no internet access, public broadcasting provides important information during emergencies and natural disasters to help keep Alaskans safe, as well as providing important community information and connection across our state. Public broadcasting also keeps Alaskans connected to their Legislature through programing on Gavel Alaska.

Without federal support, public broadcasting in Alaska will be very hard-pressed to continue delivering these vital public services. The importance of federal support for public broadcasting is underscored by the fact that, despite the Alaska Legislature's support for public broadcasting funding since 2019, that funding has repeatedly been vetoed from the state budget. That political reality, combined with our current financial shortfalls, mean that the State of Alaska will be unable to backfill the money from federal public broadcasting cuts.

Ultimately, the rescission of public broadcasting funds in H.R. 4 will have a minimal impact on addressing the federal budget deficit. However, they will have catastrophic impacts on public broadcasting and the safety and well-being of communities across Alaska. Specifically, H.R. 4 rescinds roughly \$9.4 billion in previously appropriated federal funds. This represents 0.13% of the nearly \$7 trillion federal operating budget. While we understand the importance of fiscal responsibility and addressing the federal deficit, these cuts will do more harm than good for public safety and well-being in Alaska.

With these factors in mind, we kindly request that you work to preserve public broadcasting funding for Alaska. Thank you for your consideration and your service to Alaskans.
