Coronavirus/COVID-19 Statement

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The City of Fort Lauderdale (COFL) has created new protocols and put in place preventative measures to reduce the spread of COVID-19; however, COFL cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending any program may increase your child(ren)s risk of contracting COVID-19.

Day of Registration

1. Prior to the parent entering the building, they must have a mask and pass the temperature/visual screening. Temperature will be taken, if temperature is higher than 99.0 they will not be allowed to enter the building and register at that time. They will have 24 hours to come back without a fever or send a designated person to complete the registration process with payment. If they refuse to have their temperature taken, they cannot register for camp. If they pass the screening, they will enter one at a time with mask.
2. Parents that shows up with spouse, children, and/or other family members, will be required to be screened (CDC guideline) prior to being permitted to enter the building. There will be a designated seating area for those not completing the registration process and payment. The area will be sanitized upon them leaving.
3. Parents can swipe their card individually if possible, if not the clerk will wear gloves and sanitize the gloves in between customers and in front of the next customer.
4. You will be asked to sign the following agreement at time of registration.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to, or infected by COVID-19 by attending the COFL program, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the COFL program cannot be eliminated and may result from exposure to myself and others, including, but not limited to, COFL employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks regarding COVID-19 and accept sole responsibility for any injury to my child(ren) or myself including, but not limited to, personal injury, disability, and death, illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur as a result of COVID-19 and in connection with my child(ren)s attendance at, and participation in, the COFL program. On my behalf, and on behalf of my child(ren)s, I hereby release, covenant not to sue, discharge, and hold harmless COFL, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating to COVID-19. I understand and agree that this release includes any Claims based upon any exposure to COVID-19 from COFL, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any COFL program.
