Player Registration and Payment Policy:

April 15 is the deadline to submit and pay for your player registrations for Q1 (January - March).

Use the data@usasa.com to submit new player data in an excel document [Data Template](#)

Player registrations need to be submitted no later than 15 days from the end of each calendar quarter:
March 31, June 30, September 30 & December 31.

Mail checks and completed remittance form to 7000 S Harlem Ave, Bridgeview, IL 60455 and make checks payable to USASA.

101.1.3 Player registration information and fees shall be submitted by each Organization Member no later than 15 calendar days from the end of each calendar quarter for registrations within or before that quarter. Quarters end on March 31, June 30, September 30 and December 31, respectively. Failure to timely submit quarterly player registration information and fees may result in a fine of \$1 per late player.
