10:00 – 10:15 a.m. Thriving Families, Safer Children update and how this impacts us moving forward – Roberta **Common Agenda & Mutually Reinforcing Activities**

For the past few years, five collaboratives in the state have been working on approaches to impact prevention and systems. We were one of five collaboratives in Nebraska to pioneer this work which

focused on developing approaches to community well-being that would help all families thrive and specifically help families avoid system involvement. These efforts were to be data driven, community decided and collaboratively implemented.

Our impactful work included panel presentations to schools in our four-county area where nearly 650 staff learned how law enforcement, HHS, the Child Advocacy Center, Community Prevention and the United Way work together to support children and families - they heard how vital they are to this work and ways we might even work together more effectively. These panels generated many continuing conversations about those things needed to promote families thriving in our area.

Within our group we shared information and had many meaningful discussions. We approached issues such as the needs of undocumented youth, increasing issues around chemically impacted drivers, the need to share information about changes in immigration law and the need for community planning efforts to work together on their commonalities.

As our larger collaborative work has strengthened, we are also embracing a data driven approach, sharing of information, thoughtful discussions, and implementation of new ideas. The movement of TFSC into that our larger collaborative work will strengthen these practices. As we collapse the TFSC work into the larger collaborative, we will no longer be asking you to come to separate TFSC meetings but know we can count on you to continue to be part of the effort.

Our intent is to share data with you as a larger collaborative and to make data driven decisions.

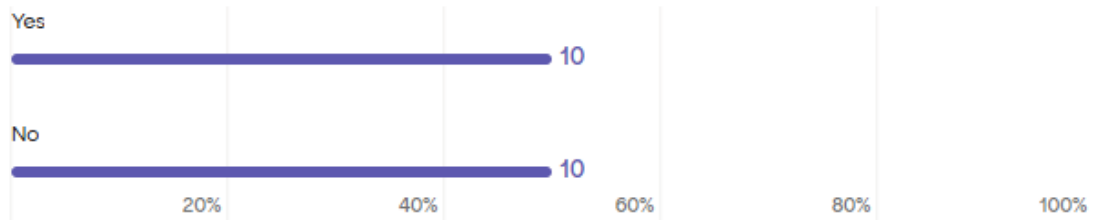

Find Help is the data collection platform used by 22 collaboratives across the state thus our Community Prevention staff use the system. Aggregated data can be pulled from Find Help which tells the story of how many people are being helped, what kind of needs they have, etc. Find Help is the system collaboratives are using and we know it is here to stay! 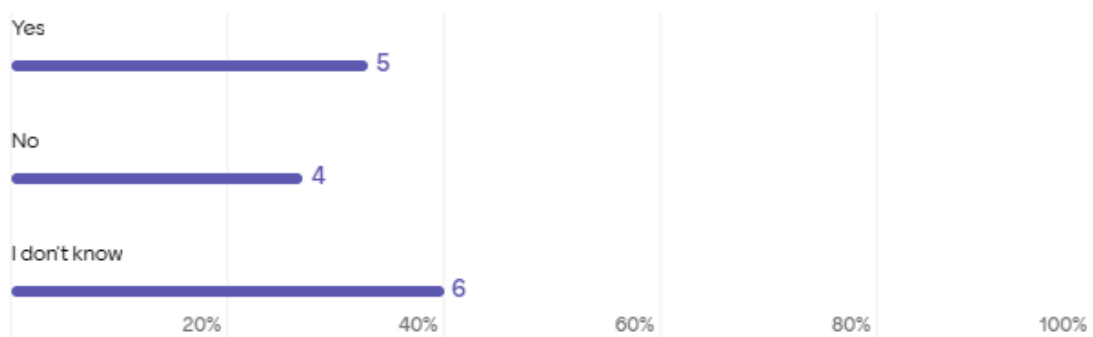
■ I've been on Find Help and searched out the agency I work with to see that the information provided on it is up-to-date.

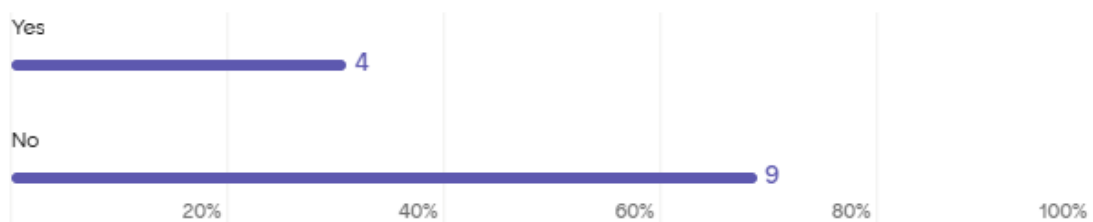
■ Is your agency accepting referrals through FindHelp?

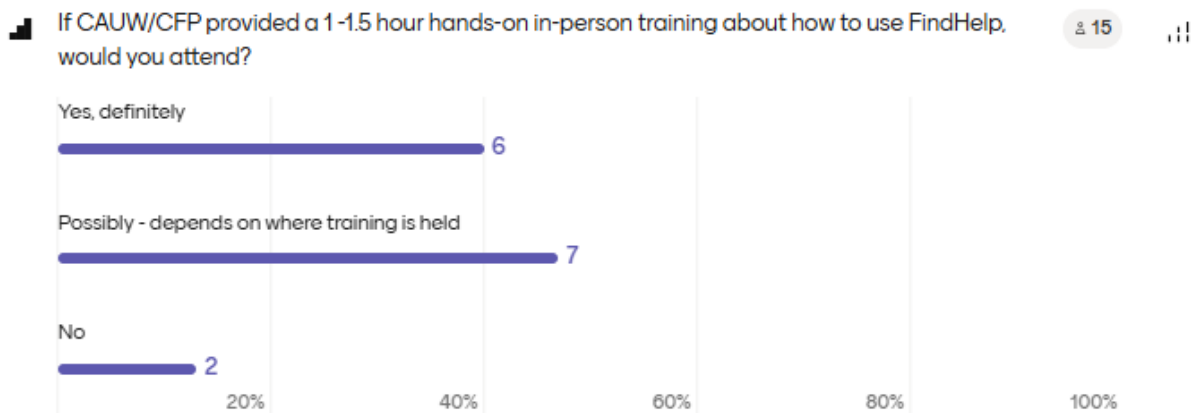
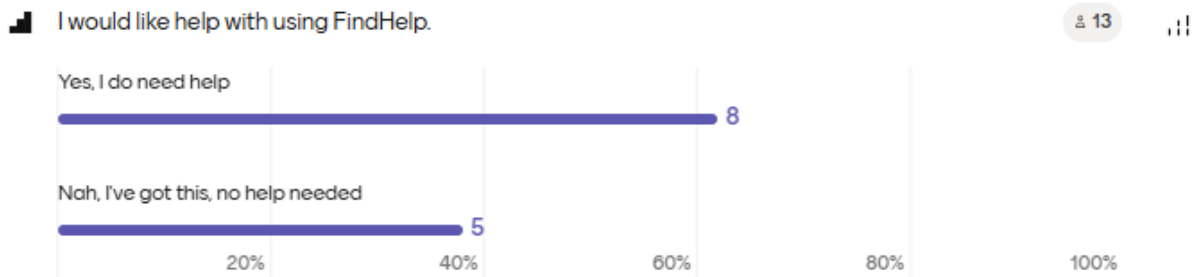
