10:10 - 10:30 a.m. Sharing NEW 2024 Child Protective Services data & conversation about what the data is telling us – Kate Wythers - CAUW/CFP

 55 removals in our four-county area. 296 accepted intakes for a total of 764 children. Numbers increased between 2023 and 2024. Of "Do Not Meet Definition" intakes – 56% physical neglect, 24% physical abuse. Educational personnel are the largest reporters. Education and resources are important as some families are trying their best, but do not have the resources or knowledge.
