1. Raise the Bar | Unlocking Career Success



Through the <u>Unlocking Career Success initiative</u>, **OCTAE reimagined how U.S. high schools prepare all students to thrive in future careers.** The initiative blurs the lines between high school, college, and career, providing students with accelerated and innovative opportunities to earn college credits and gain real-world career experiences. Strong futures can be built on the four keys to Unlocking Career Success: <u>dual enrollment</u>, <u>work-based learning</u>, <u>industry recognized credentials</u>, and

career advising and navigation.

- <u>Career-Connected High Schools</u>: In January 2024, the Department announced 19 grant awards totaling \$25 million through the Perkins Innovation and Modernization, Career-Connected High Schools (CCHS) grant program. This investment builds the capacity of education and workforce systems to partner with business and industry to develop high-quality career-connected high school programs for more students.
- <u>Unlocking Career Success Playbooks</u>: OCTAE published 26 playbooks with strategic and tactical actions stakeholders can take to develop and expand programs with clear on-ramps to high-quality jobs.
- <u>Unlocking Pathways State Policy Heat Map</u>: OCTAE published an interactive map to recognize how state policies can
 impact career pathways programs. This tool compiled 20 policies centered on the 4 keys that are essential to
 cohesive career-connected ecosystems and reflects the number of policies each state has enacted.

2. Adult Education



Over the course of the Biden-Harris Administration, OCTAE made strides to establish new flexibilities and supports that encourage states and local adult education providers to design programs and measure their progress toward achieving meaningful outcomes for adult learners. Among the changes that were introduced were new and revised Measurable Skill Gain types for the passage of high school equivalency tests and enrollment in postsecondary education and training. OCTAE also issued a program memo clarifying that Adult Education and Literacy Act funds can be used for supportive services, such as transportation and childcare, when those services enable learners to participate and persist in adult education programs. OCTAE also continued to build on its system of technical assistance and professional development to adult education providers through Literacy Information and Communication System (LINCS), a webinar series, and a variety of National Activities.

Key Activities:

- Aligning Non-Credit and Credit: ED published a <u>blog</u> and hosted a webinar with the Association of Community
 College Trustees (ACCT) on exemplars for alignment and strategies to leverage Perkins V.
- Ability to Benefit (ATB): In 2023, <u>final regulations</u> were published on ATB. In 2024, ED published <u>guidance</u> on the ATB state process and eligible career pathways programs.
- Adult Numeracy Instruction <u>2.0</u> is an evidence-based, fully online program to support standards-aligned mathematics instruction for adults.
- <u>Digital Resilience in the American Workforce</u> (DRAW): Through DRAW, OCTAE supports states' efforts to implement
 digital literacy instruction in adult education and literacy programs by preparing practitioners to support learners' use
 of digital tech.
- Advance Integrated Education and Training (ADVANCE IET): Through ADVANCE IET, OCTAE helps adult education staff plan, design, implement, and evaluate effective IET programs and service approaches responsive to labor market demands.
- <u>Standards in Action</u>: This initiative provides accessible professional development, helping teachers implement state-adopted content standards for adult education. It will assist states in meeting the WIOA requirement that adult education services shall lead to high school completion and entry into postsecondary education and training or employment.

- <u>Teaching Skills That Matter in Adult Education (TSTM)</u>: TSTM trains teachers to integrate skills (e.g., critical thinking) that matter to adult students, using approaches that work across critical topics.
- Supporting Adult English Learners' Participation in IET: This project provides resources and technical assistance to adult education state agency staff, local programs, and instructors who serve or are aiming to serve English learners in IELCE programming and are interested in using an immigrant integration approach.

3. Career and Technical Education



Update! In January of 2025, OCTAE published two open grant programs. Both the <u>Native American Career and Technical Education Program</u> (NACTEP) and Native Hawaiian Career and Technical Education Program (NHTEP) Notice Inviting Applicants are LIVE. For more information on both programs, refer to our website <u>here</u>. Applications must be submitted through Grants.gov.

Over the Biden-Harris Administration, OCTAE has sought to remove barriers in Career and Technical Education and strengthen career pathways. To support the advancement of cybersecurity education, OCTAE recognizes the nation's leading cybersecurity educators at the elementary and secondary school level through the Presidential Cybersecurity Education
Award. To strengthen CTE, OCTAE operates three key Perkins V discretionary grant programs. In addition to NACTEP and

NHTEP, the Tribally Controlled Postsecondary Career and Technical Institutions Program (TCPCTIP) supports tribally controlled postsecondary career and technical institutions.

OCTAE hosted a series of challenge prize competitions to support America's innovators, strengthen CTE, and expand pathways to great jobs. The <u>Career Z Challenge</u> sought creative solutions to expand high-quality work-based learning opportunities. In August 2024, 10 finalists were selected to complete Phase 2 (ending in 2025) and immersed in an accelerator. In the Fall of 2024, the <u>CTE CHIPS Challenge</u> was launched to expand student recruitment, training, and placement strategies in semiconductor fabrication (fab) construction and advanced manufacturing careers that align with the CHIPS and Science Act (CHIPS). Semi-finalists will be announced in February 2025.

Through OCTAE's <u>CTE Momentum</u> initiative, OCTAE annually invites educators and high school students to participate in a challenge focused on a topic of national importance. The <u>Your Place in Space Challenge</u> invited teams to submit designs for a product or service that advances space missions and exploration. <u>The Power Your Future Challenge</u> invited teams to submit action plans that will advance the use of clean energy in their schools and communities. In February 2025, the Department will announce the winning teams.

4. Correctional Education



The Biden-Harris Administration has been instrumental to the advancement of correctional education initiatives. We participated in the Alternatives and Reentry Council, working across ED to gather policy recommendations: report. In 2023, the Department launched a new Second Chance Pell experiment to allow current participants to continue serving students after July 2023. In July 2023, Prison Education Programs (PEP) were fully implemented by new regulations. While many Second Chance Pell programs are still transitioning to PEP status, there are now 64 approved PEP programs across 21 institutions. Click here for list of approved PEPs. OCTAE also launched an <u>Integrated Education and Training in Corrections</u> (IETC) initiative, providing resources and technical assistance to help adult education and corrections staff plan, design, implement, and evaluate effective IET programs and service approaches in correctional facilities through a design camp model outlined in the <u>IET Design Toolkit</u> and <u>IET in</u> Corrections: Companion Guide Design Toolkit.
