Find Currently Active DOL Grantees Across the Country, Including in Your Community!

The U.S. Department of Labor (DOL) recently launched an [interactive map](#) on dol.gov/grants depicting the headquarter locations of all currently active grantees from across agencies and demonstrating the international footprint of Bureau of International Labor Affairs projects overseas.

The map includes the Employment and Training Administration, Veterans' Employment and Training Service, Women's Bureau, Occupational Safety and Health Administration, Mine Safety and Health Administration, and Office of Disability Employment Policy. The map is searchable by Keyword, and can be filtered by Agency, Fiscal Year, State, and Amount.

The purpose of this map is to provide a tool to partners, organizations, and members of the general public to find DOL-funded organizations working in their communities, and to support place-based partnerships by helping to connect the ecosystem of grantees, [American Job Centers](#), [State and Local Workforce Boards](#), [Apprenticeship Providers](#), and localized data from the [Bureau of Labor Statistics](#). H-1B Scaling Apprenticeship Through Sector-Based Strategies: The H-1B Scaling Apprenticeship through Sector-Based Strategies grant program supports sector-based approaches to expanding apprenticeship on a national scale and increases apprenticeship opportunities for all Americans. This community provides Scaling Apprenticeship grantees with a place to interact with grant peers and access the latest program technical assistance and resources.

H-1B Skills Training: The H-1B Skills Training Community provides practitioners with workforce information and technical assistance resources that will support educational and job training programs with promising practice strategies to move individuals along their career pathways toward employment in middle-to-high-skilled jobs.

H-1B Strengthening Working Families Initiative (SWFI): The SWFI Community is designed to provide grantees with a central place to find resources to successfully implement SWFI grants. This community supports efforts to ensure that participants receive comprehensive job training, childcare, and other support services which move them into and along H-1B-aligned career pathways.

H-1B America's Promise: The H-1B America's Promise grant program strengthens the pipeline of skilled workers to expand an economic region's middle- to-high-skilled workforce. These grants prioritize one or more H-1B industry sector(s) and help America's workforce gain the necessary skills to fill in-demand jobs and increase the long-term competitiveness of the local region.

H-1B TechHire: The H-1B TechHire grant program is a key component of the TechHire Initiative. This bold multi-sector effort provides American workers with critical information technology skills for today's high-growth careers.
