**No. 2020-04**

**EXECUTIVE ORDER**  
(COVID-19 Pandemic Response)

In light of the ongoing public health crisis arising from the novel coronavirus (COVID-19) pandemic occurring across the world, the State of Emergency declared by the Governor on March 9, 2020, and guidance provided by the Rhode Island Department of Health in conjunction with the federal Centers for Disease Control and Prevention, and pursuant to the authority invested in me by § 8-15-2 of the Rhode Island General Laws, the following order is hereby issued to protect the public health, safety, and welfare by reducing the risk of exposure to COVID-19 and slowing the spread of the disease.

It is hereby ordered as follows:

**Trials and Non-Essential Matters** – Except for those matters specifically identified by court below as Emergency/Essential, all matters shall be continued as follows in accordance with the specific directives of the respective courts:

1. All Superior Court jury trials shall be continued until after April 17, 2020.
2. All Superior Court grand jury proceedings shall be suspended until after April 17, 2020.
3. All other matters in all courts within the unified judicial system shall be continued until after April 17, 2020.

**Emergency/Essential Matters** - The following matters shall continue to be heard before the appropriate court and in the appropriate judicial building<sup>1</sup> as of the date of this Executive Order.

**Deadlines** - All payment dates and court-imposed filing deadlines are hereby extended for thirty (30) calendar days from the date of this Order. Requests for extensions to applicable statutes of limitations necessitated by the current health crisis shall be entertained by the respective courts after thirty (30) calendar days from the date of this Order. Where available, parties and their counsel should continue to utilize the electronic filing system for appropriate and timely filings. Pro se litigants may utilize the electronic filing system or submit filings by mail or other means, as allowed pursuant to administrative orders promulgated by each of the respective courts.

**Judicial Buildings** – The following procedures shall be instituted in each judicial building:

1. Judicial officers and essential personnel shall be allowed to enter the judicial buildings.
2. Only litigants and other necessary parties required to appear in connection with the emergency matters identified above shall be allowed to enter the judicial buildings.
3. The Judicial Records Center and Fogarty Judicial Annex shall be closed to the public.

**Video** – Courts are encouraged to utilize videoconferencing tools whenever possible.

**Duration** - The foregoing measures shall remain in place through April 17, 2020 or until such time that a new Executive Order is issued revoking or amending this Order.

**Court-specific Guidance** - The Presiding Justice of the Superior Court, the Chief Judge of the Family Court, the Chief Judge of the District Court, the Chief Judge of the Workers' Compensation Court, and Chief Magistrate of the Traffic Tribunal may promulgate appropriate administrative orders in accordance with the foregoing directives and are authorized to make appropriate and limited exceptions where necessary and/or constitutionally required. Any requested exceptions to the foregoing order shall be heard and decided by the highest-ranking judicial officer in each of the respective courts.
