Coalitions and Collaboratives Inc. (COCO): Implementation and Mitigation (AIM) Program

Deadline: February 23, 2024

Amount: \$10,000 to \$75,000

Match: Yes - 1:1

Eligibility: Fire departments, conservation districts, regional/local collaborative efforts, Fire Safe and/or Wildfire Councils, nonprofits in partnership with local/state/private entities, cities, counties and tribal governments

Summary: Program goal is to accelerate fire adaptation concepts and reduce the risk from wildfire across the U.S. by increasing capacity and on-the-ground work. COCO hopes to increase community resilience, restore fire-adapted ecosystems and create safer conditions for residents and firefighters. This funding opportunity is open to organizations working to advance wildfire risk reduction. Program funds organizations across the country with a focus on programs and projects that increase communities' ability to overcome barriers to successful community wildfire mitigation, multiply the efforts, achieve quantifiable outcomes, support equitable and inclusive community wildfire mitigation programs across the fence, and support place-based solutions.

CaLFIRE: Wildfire Resilience and Forestry Assistance Grant

Deadline: February 26, 2024, 5:00 p.m. PST.

Amount: Up to \$7 million may be awarded through this grant solicitation for projects addressing Action Items 1.11, 1.13 and 1.14. The minimum grant request should be no less than \$1 million. The maximum allowable is \$3 million. Up to \$1 million may be awarded through this grant solicitation for projects addressing Action Item. 1.10. The minimum grant request should be no less than \$500,000.

Eligibility: Applicants submitting projects addressing action items 1.11, 1.13 and 1.14 are limited to Resource Conservation Districts (RCD's) and special districts capable of acting as lead agency for CEQA projects. These applicants must demonstrate they have the capacity to deliver a forestry based technical and financial assistance program to non-industrial forest landowners. Applicants submitting projects addressing action items 1.10 are limited counties, resource conservation districts, special districts, and 501(c)(3) non-profit organizations.

The purpose of the block grant is to allow prospective grantees the ability to provide a program of financial and technical forestry assistance to nonindustrial forest landowners, where the grantee serves as the supervising entity, receives the grant from CAL FIRE and then provides outreach and/or technical/financial assistance to landowners so they can conduct forest restoration or management activities on their property.

CAL FIRE's Wildfire Resilience team seeks to maintain and enhance the resilience of California's

small non-industrial private forestland owners to promote healthy resilient forests throughout the state by supporting a diverse set of projects designed to interact with landowners. Depending on the grant objectives, grants can prove the following:

- Funding of forest improvement practices including but not limited to tree and brush thinning, tree release, pruning, site preparation and tree planting, follow up work to support tree growth, and/or slash disposal.
- Technical assistance

This program remains dependent on special funds.

AFG-Assistance to Firefighters grant

Deadline: Open Jan. 29 through March 8, 2024

Amount: Varies

Match: Yes, but exceptions if you meet a certain req.

CAL FIRE: Business and Workforce Development

Deadline: March 8, 2024 (11:59pm)

Amount: \$20,000,000 Total Available; Number and Amount of Each Award Varies

Match: Match requirement varies depending on project type. Business development projects between \$10,000-\$500,000 require a 100% match. Business development projects between \$500,000-\$2,000,000 require a 200% match. Workforce development proposals less than \$500,000 do not require match. Workforce development proposals between \$500,000-\$5,000,000 require a 10% match.

Eligibility: Business, Individual, Nonprofit, Other Legal Entity, Public Agency, Tribal Government (Statewide)

The purpose of this program is to recruit and train EMS personnel in rural areas with a particular focus on addressing substance use disorders (SUD) and co-occurring disorders (COD) substance use and mental disorders. Recipients will be expected to train EMS personnel on SUD and COD, trauma-informed, recovery-based care for people with such disorders in emergency situations and, as appropriate, to maintain licenses and certifications relevant to serve in an EMS agency.

County Coordinator Grant Opportunity

The County Coordinator Grant Program is part of a larger effort by the California Fire Safe Council and our partners to develop local and regional capacity and coordination to encourage collaboration between all fire mitigation and emergency preparedness groups, as well as government agencies and stakeholders. Each County Coordinator will serve as a conduit of information and resources and provide active coordination and outreach efforts within their county.

Rural Fire Capacity (RFC) Grant:

Deadline: TBD, coming out in March 2024

Amount: \$500 to \$20,000

Match: 50%

Federally-funded grant program that allows California to provide local and rural fire departments with minor firefighting, training, communications and safety equipment for their volunteer firefighters. The RFC Program is not intended for major equipment (fire engines, vehicles, etc) or Capital repairs. The RFC Program has a 50/50 match requirement which means that the applying department must be able to meet the intended grant award, dollar for dollar. Awards for departments are set at a minimum of \$500 with a maximum of \$20,000. Amounts may be adjusted based on the grant funding available.

The Fire Prevention and Safety (FP&S) Grants are part of the Assistance to Firefighters Grants (AFG) and support projects that enhance the safety of the public and firefighters from fire and related hazards. The primary goal is to reduce injury and prevent death among high-risk populations. In 2005, Congress reauthorized funding for FP&S and expanded the eligible uses of funds to include

Firefighter Safety Research and Development.

Staffing For Adequate Fire and Emergency Response (SAFER)

The Staffing for Adequate Fire and Emergency Response Grants (SAFER) was created to provide funding directly to fire departments and volunteer firefighter interest organizations to help them increase or maintain the number of trained, "front line" firefighters available in their communities. The goal of SAFER is to enhance the local fire departments' abilities to comply with staffing, response and operational standards established by the NFPA (NFPA 1710 and/or NFPA 1720). In this upcoming cycle, funding priority will be given to those applicants whose climate-driven wildfire and other disaster prevention or preparedness projects serve under-resourced communities at heightened wildfire risk or traditionally vulnerable populations.

Up to \$25K available for each eligible project. In response to feedback and the needs of communities, the Foundation is excited to be able to offer larger awards in this cycle. Community Wildfire Prevention and Mitigation

Deadline: 2024 (est.)

Amount: up to \$500,000

As part of the State of California's effort to strengthen community-wide resilience against wildfires, the California Governor's Office of Emergency Services (Cal OES) has partnered with the California Department of Forestry and Fire Protection (CAL FIRE) to develop a state home hardening initiative to retrofit, harden, and create defensible space for homes at high risk to wildfires, focusing on high socially-vulnerability communities and providing financial assistance for low- and moderate-income households. Governor Gavin Newsom signed Assembly Bill 38 in 2019 authorizing Cal OES and CAL FIRE to enter into a joint powers agreement to oversee the development and implementation of the Program.

Known as the Home Hardening Program, this effort encourages cost-effective wildfire resilience measures to create fire-resistant homes, businesses, public buildings, and public spaces. Mitigation

measures such as home hardening, vegetation management, defensible space, and other fuel modification activities provide neighborhood or community-wide benefits against wildfire.

Regional Catastrophic Preparedness Grant Program

Amount: Around \$500,000

The Regional Catastrophic Preparedness Grant Program (RCPGP) plays an important role in the implementation of the National Preparedness System. RCPGP supports the building of core capabilities essential to achieving the National Preparedness Goal of a secure and resilient nation by providing resources to close known capability gaps in Housing and Logistics and Supply Chain Management, encouraging innovative regional solutions to issues related to catastrophic incidents, and building on existing regional efforts.

USDA Community Wildfire Defense

Deadline: October 2024 (est.)

Amount: The maximum amount of Federal funding awarded to any one community or Tribe via this competitive process is:

- \$250,000 for the creation or updating of a Community Wildfire Protection Plan.
- \$10 million for a project described within a Community Wildfire Protection Plan less than 10 years old.
- For planning purposes, the total Federal funding available through the CWDG competitive process could be up to \$250 million for this second round.

This program, which was authorized by the Bipartisan Infrastructure Law, prioritizes at-risk communities in an area identified as having high or very high wildfire hazard potential, are low-income, or have been impacted by a severe disaster that affects the risk of wildfire. More details on these three priorities can be found in the Notices of Funding Opportunity (NOFOs) below.

The program provides funding to communities for two primary purposes:

- Develop and revise Community Wildfire Protection Plans (CWPP).
- Implement projects described in a Community Wildfire Protection Plan that is less than ten years old.

The Community Wildfire Defense Grant Program also helps communities in the wildland urban interface (WUI) implement the three goals of the National Cohesive Wildland Fire Management Strategy.

Restore and Maintain Landscapes: Landscapes across all jurisdictions are resilient to fire-related disturbances, in accordance with management objectives.

Create Fire Adapted Communities: Human populations and infrastructure can better withstand a wildfire without loss of life and property.

Improve Wildfire Response: All jurisdictions participate in making and implementing safe, effective, efficient risk-based wildfire management decisions.
