6. That this instrument sets forth the entire understanding between the parties on this matter and that there are no other agreements, oral nor written, between the parties with regard to the subject matter contained herein.

7. This Agreed Judgment is final and disposes of all claims and all parties in this suit. The Agreed Judgment shall not waive any private rights, causes of action, or remedies of any claimant against Defendant with respect to the practices or conduct described herein.
