



## Social Service Designee Certification In-Person Workshop

**November 10-12, 2021**

The Louisiana Nursing Home Association (LNHA) invites social service directors in the long-term care profession to attend the in-person Social Service Designee Certification Workshop on November 10-12, 2021. This three-day training program is a structured educational curriculum that fully orients, educates and certifies those who wish to work in Louisiana nursing facilities as a social service designee / director. The workshop will be presented by Jeff DeMars, BSW, MCCC, LNFA, CDCS, CDBS, CCDC, ADC/EDU, ACC-BC with guest speaker Tazyia Bailey, MSW, LMSW.

Objectives of the seminar include:

- Identify the role of the Social Service Designee (SSD)
- Identify regulations, policies and best practices for the SSD role
- Create an individualized care plan and describe the social service components of the plan
- Learn to explain and complete the MDS 3.0 for the SSD discipline
- Understand the SSD role and learn how to work with an ID Team
- Understand the components of a psychosocial assessment and proper documentation of psychosocial needs
- Understand the survey process and what surveyors look for with social services
- Comply with the LDH-OBH requirements for mental illness, substance abuse and trauma
- Identify crisis intervention strategies to use
- Use strategies and skills for working with chronic mental illness in the long-term care arena
- Differentiate between dementia and schizophrenia
- Learn how to design an effective family council
- Learn how to use productive and effective documentation to reflect the level of care validation
- Learn to explain and advocate for resident rights
- Use effective marketing strategies to enhance census development
