***Effective January 1, 2023**

Churches are required to pay a minimum Pulpit Supply of \$200 for one service with an additional \$50 for each additional service held on the same day or when multiple trips to the church are needed to prepare recorded messages, etc. This includes mileage.

The minimum payment for Session Moderation shall be \$150 for the first two hours of the Session or Congregational meeting. If the meeting goes beyond two hours, the additional fee is \$50.00 additional hour. This includes mileage. (This applies to pastors who moderate session or congregational meetings for a church other than the one they serve as pastor.)

Churches are further advised to request a W-9 from all teaching elders who provide at least \$600 worth of services in a single calendar year, and churches are required by the IRS to issue a 1099 for all individuals who receive at least \$600 in yearly compensation. Teaching elders should take note that their mileage to and from pulpit supply and moderator duties may be deducted from their taxes.
