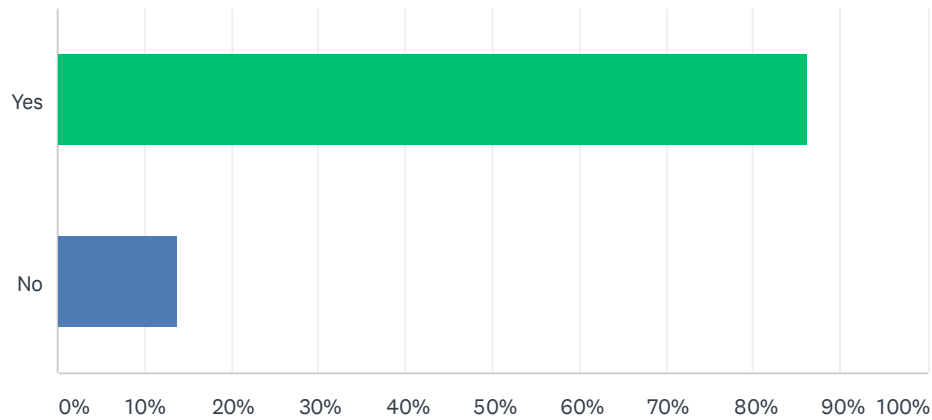


Q1 Do you have a virtual visitation policy/procedure in place at your assisted living community?

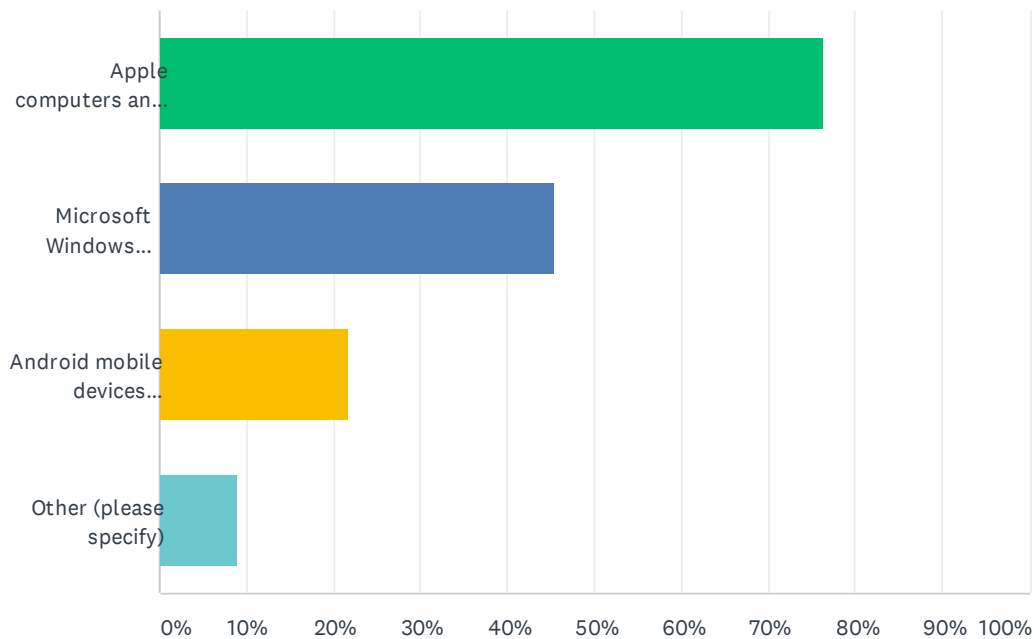

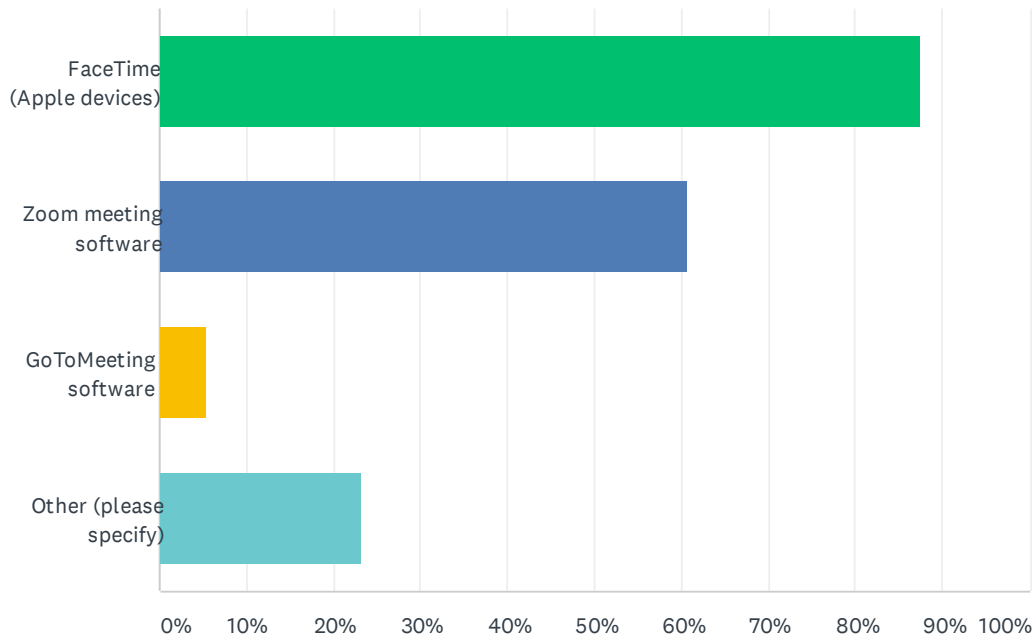

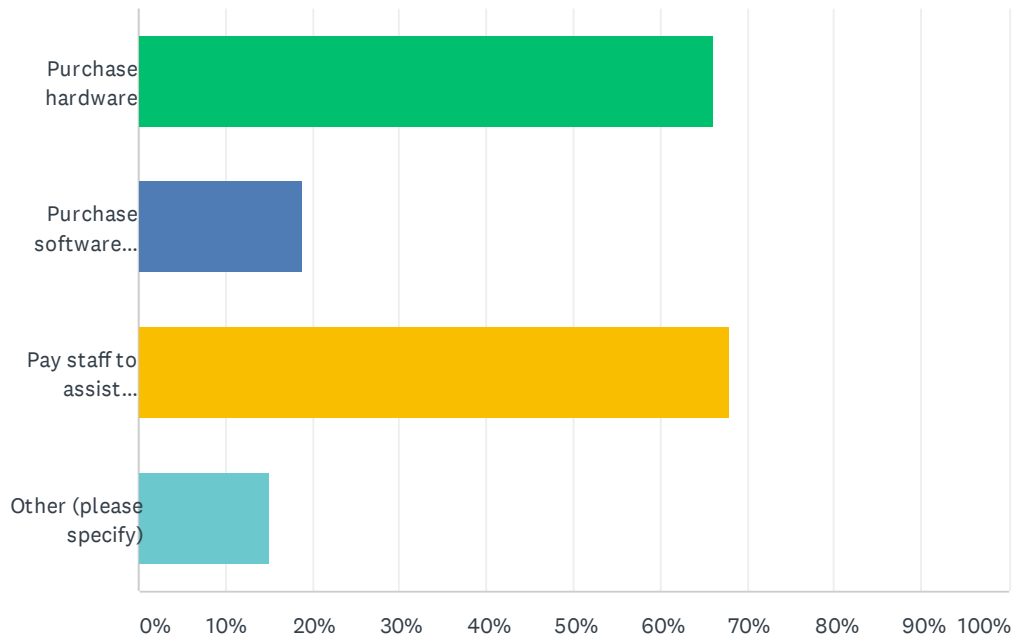

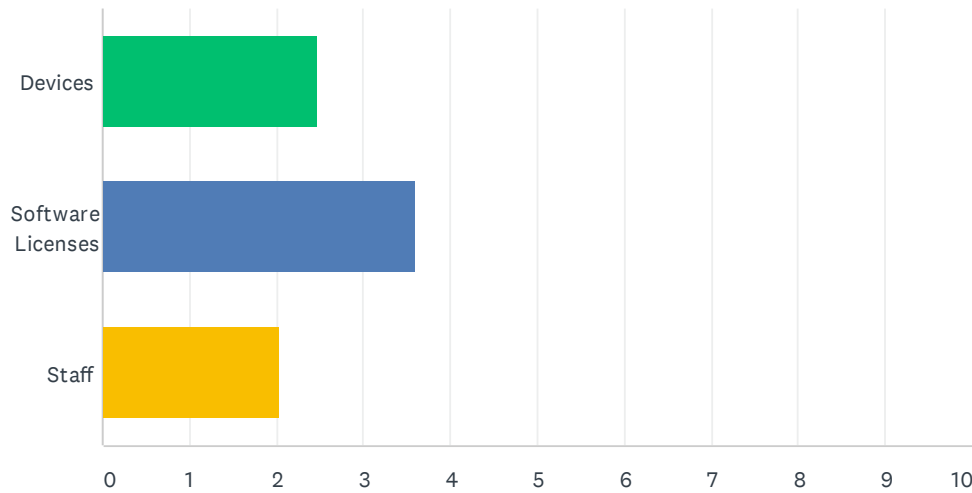
