Initiative to Reduce Tobacco-Related Disparities at Residential
Behavioral Health Facilities

Purpose:

The purpose of this Request for Application (RFA) is to fund up to 15 Wellness Quality Improvement Projects to reduce tobacco-related health disparities and diminish tobacco use among people with substance use disorders and mental illness in local community residential behavioral health facilities, alcohol and drug treatment programs, mental health treatment programs, or other health or social service agencies through the adoption and implementation of tobacco-free campus and evidence-based tobacco cessation policy.

Grantees may be community residential behavioral health facilities, alcohol and drug treatment programs, mental health treatment programs, and other health or social service agencies located in counties throughout California.

Applications must address the following priority areas: 1) Promote Tobacco Cessation; and 2) Reduce Exposure to Secondhand Smoke, Tobacco Smoke Residue, Tobacco Waste, and Other Tobacco Products.

Statutory Authority: California Health and Safety Code Section 104390(a)(b) & 104375(f)

Term: November 1, 2018 through April 30, 2020*

Funding: Funding will be available from the *California Healthcare, Research, and Prevention Tobacco Act of 2016*, Proposition 56. The total amount of funding available is up to \$540,000 to fund up to 15 projects for the 18-month grant period. Funding is contingent upon available revenues and appropriations by the Legislature and the Governor's Budget for fiscal year (FY) 2017-18 and subsequent FYs.
