During the first week of October, 2018, KaDonna Randolph, research mathematical statistician, and Jim Alegria (Forest Service, retired) led a four-day training on national forest inventory data analysis for FIA's equivalent in the Democratic Republic of Congo (DRC) known as DIAF (Direction des Inventaires et Amenagement Forestiers). This International Programs-sponsored training was held in Kinshasa, DRC, in partnership with the U.S. Agency for International Development (USAID), SilvaCarbon, and the

Food and Agriculture Organization (FAO) of the United Nations. The training consisted of classroom instruction on probability and statistics with direct application to population-level estimation of forest area, tree density, aboveground biomass, and biodiversity. The ten DIAF participants were presented certificates of completion by the Secretary General of the DRC Ministère de l'Environnement et Développement Durable (Ministry of the Environment and Sustainable Development).

## **Staffing Changes in SRS FIA**

Ali Conner is retiring at the end of December, 2018. Ali has been leading the SRS FIA Information Management (IM) Section for the past 15+ years. She has been a great leader, manager, and supervisor of the IM Section. In addition, she has worked at the National FIA level helping to deliver the FIA Program. She was instrumental as the Project Manager in moving FIA from four regional data collection, processing, and reporting functions for Timber Product Outputs (TPO) to a National system for TPO. Currently Jeff Turner is in a 120-day detail as the acting Section Head for the Information Management group.

Robert Lee is the new SRS FIA Deputy Program Manager as of October 29, 2018. Robert began his career in forestry as a youth working with his father and his six brothers in the family logging business. His father, who is now 86 years old, purchased timber sales from the Forest Service on the Conecuh Ranger District located in South Alabama. At age 15 he landed a summer job with the Forest Service as a member of the Youth Conservation Corp (YCC) which was a program designed to expose young people to the natural resource field. After receiving his degree in Forest Management at Auburn University he began his career with the Forest Service on the Tuskegee Ranger District in 1988 as a GS-04 Timber Marker. Since that time, he has served in numerous roles with the

FS—on the National Forests in Mississippi, on the Cherokee National Forest assisting with the coordination of the 1996 Olympic Canoe and Kayak Event held on the Ocoee River, as Operations Team Leader during the aftermath of Hurricane Katrina, as the Deputy Director of Renewable Resources in Region 2, also Acting Director of Renewable Resources in Region 2, acting Area Supervisor at the Land Between the Lakes in Kentucky, acting Forest Supervisor on the Kisatchie National Forest in Louisiana, and the acting Deputy Forest Supervisor on the Coronado National Forest in Arizona. On a personal note, Robert indicated what is most important to him is “wholesome communication and fostering good relationships.” Welcome aboard Robert!

Five new field crew members have started with SRS FIA, all based in Louisiana. Alan Oglesbee is in his second stint with SRS FIA in Hammond, LA. Josh Kirby comes to us from the RMRS FIA field staff and will be working out of Pineville, LA. He is paired with Dylan Schneider who comes from the Superior National Forest in Minnesota. The final two field staff—Brad Bailey, who comes with 12 years of prior FIA experience with the Texas Forest Service, and Alyssa Reid who comes to us from the White Mountain NF in New Hampshire. 

**FIA** is a USDA Forest Service research work unit which collects, analyzes, and reports on data pertaining to our forest land in the Southern region. This region includes Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, Oklahoma, Puerto Rico, South Carolina, Tennessee, Texas, the U.S. Virgin Islands, and Virginia.

FIA conducts this program of research to improve the understanding of the Southern forest ecosystem.

Government and private agencies utilize this data to monitor forest resources, forest use, and forest health. The collection of data is done on private and public land.

Our system development success is a direct result of our partners, our talented scientists, analysts, computer specialists, and other staff members who have continually contributed to the mission of this complex project.
