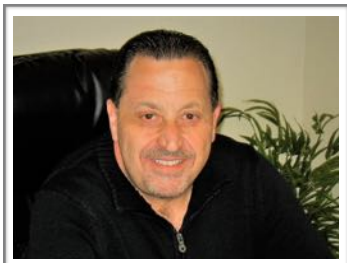

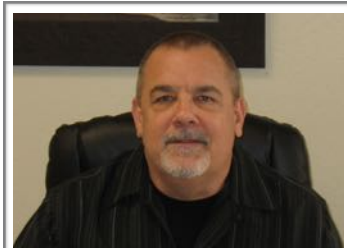
### **Information Night: Modern Day Substance Use Education & Treatment**

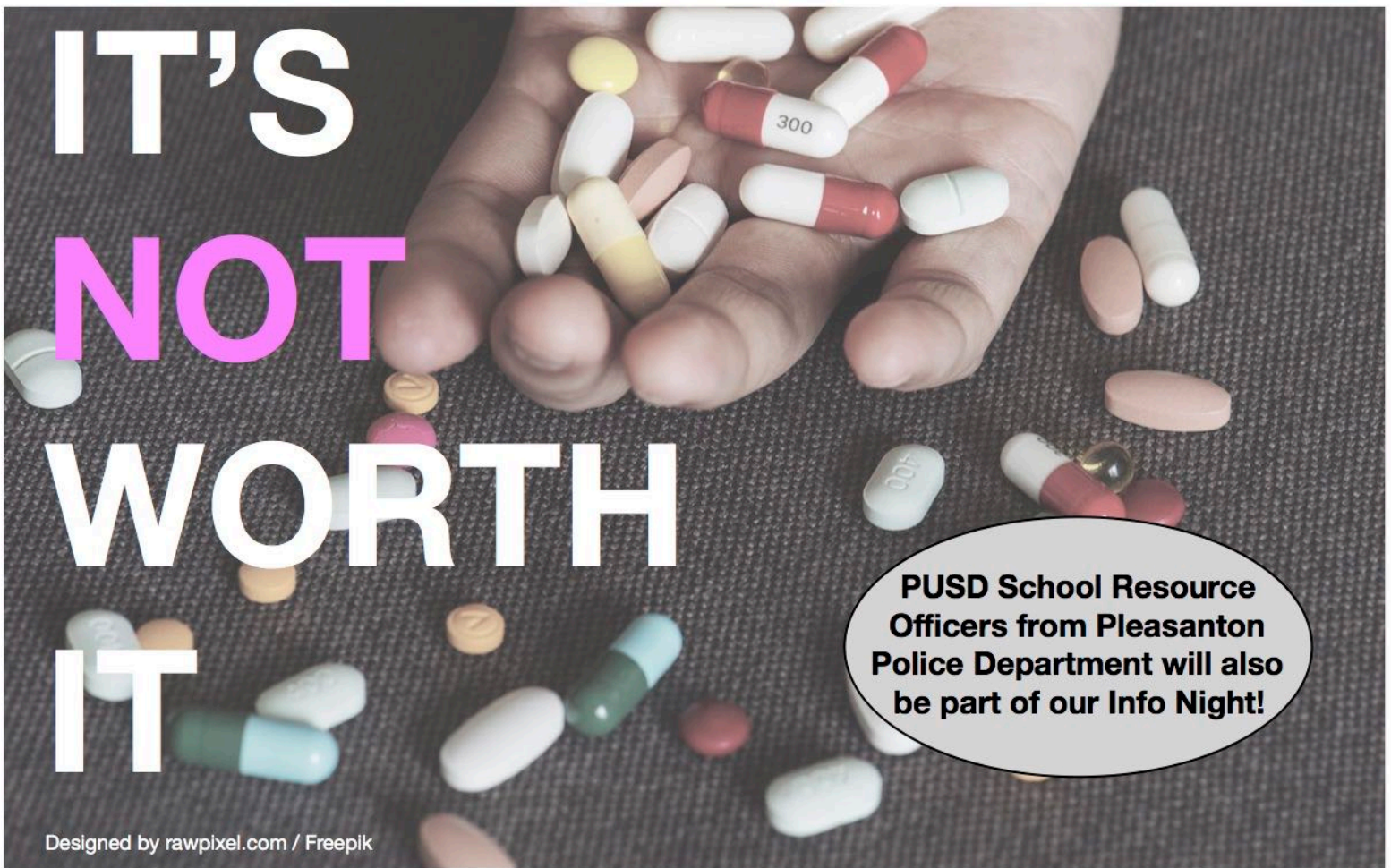

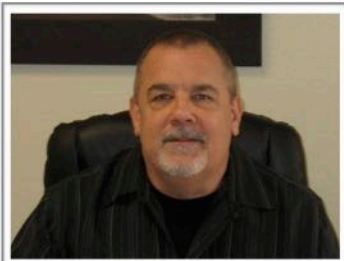
