

**ANTHONY WAYNE SCOUT RESERVATION**  
**CAMPSITE ADOPTION PROGRAM PROPOSAL**

**EFFECTIVE:** January 1, 2020 (*upon taking effect, all previous agreements and campsite adoptions will be considered null in void*).

**PURPOSE:** Partnership between units of the Anthony Wayne Area Council and the Council Properties Committee to provide well-maintained campsites that reflect the Camp Chief Little Turtle/BSA brand, and support the outdoor program at CCLT.

**ADOPTION AGREEMENT:**

*Adopting Unit agrees to the following:*

1. Each year provide one day of service (outside of summer camp) to maintaining the campsite to include brush clearing, trimming, fire-ring cleaning, firewood stacking, and basic maintenance on the latrine and washstand.
2. Participate in at least one of the semi-annual Woodcutters Day or other scheduled camp service day.
3. Complete at least one significant campsite improvement project during the three-year adoption. Examples include installation of a permanent flagpole, construction of new stairs, bulletin board, or picnic tables. All significant improvements must be pre-approved by the Council Properties Committee using approved plans.

*The Anthony Wayne Area Council, in turn, agrees to the following:*

1. Provide one free camping weekend at the adopted site\*.
2. Provide signage in the site to recognize the adopting unit.
3. Provide recognition of units that have adopted sites through appropriate means (ie social media, program guides, etc).
4. Provide all necessary tools for general site maintenance when requested (does not include building materials for significant campsite improvements).

*\*Units must schedule the camping weekend with the Council Service Center. Site reservations are first-come-first serve.*

The Anthony Wayne Area Council Properties Committee may revoke the adoption from a unit that fails to meet the above criteria. Units that do not recharter will be immediately dropped from the adoption program.

**APPLICATION PROCESS:** Units wishing to adopt a site must apply using the Campsite Adoption Application and submit to the Council Properties Committee for approval. Units that are approved for adoption will be notified in writing and the adoption period will begin immediately (from date of approval) for a period of three years. Units will be expected to reapply at the conclusion of the adoption period.
