3. SVTS has not authorized and does not endorse any external organization to:
 - a. raise funds,
 - b. solicit sponsorships,

4. All external/ off-site events, pujas, learning and social initiatives hosted by SVTS, as well as all communications, will be promoted and delivered through official channels listed on the left margin of this letterhead.

6. Donations to SVTS should be made directly through the designated official channels to maintain transparency and accountability.
7. It is important to note that SVTS cannot be held responsible for any funds given to other organizations or individuals asserting that they are raising funds on behalf of SVTS.
8. SVTS does not support any attempt to misguide or coerce people to follow any guru or spiritual path. This goes against the core principles of Sri Vidya, Sanatana Dharma and the ethical standards maintained at SVTS.
