Forgivable Business Loans Under the Paycheck Protection Program to Reopen Next Week

– The federal [Paycheck Protection Program \(PPP\), which provides forgivable loans to businesses, will reopen the week of Jan. 11, the SBA announced today](#). Initially only community financial institutions will be able to make the loans. The loans will be open to all participating lenders “shortly thereafter.” The Program’s eligibility has been expanded to include 501(c)(6)s, housing cooperatives and direct marketing organizations. Be Prepared to Apply for a Loan – The N.J. Chamber suggests that any organization interested in applying for a PPP loan begin discussions with their bank now so they can be ready to fill out the application as soon as it is available.

Details on New Jersey’s New Economic Recovery Act – Gov. Phil Murphy said the legislation – which includes the return of tax incentives for companies that create new jobs in New Jersey – will provide relief for businesses while transforming economic development in the state. The First Vaccine Mega-Site Opens – [A former Sears at a shopping mall in Rockaway opened Friday morning as the first of six planned “mega-sites”](#) New Jersey is setting up for mass vaccinations for the coronavirus, though rollout of the vaccine continues to be slower than officials want. The COVID-19 Vaccine is Completely Covered by Insurance and Those Without Insurance Won’t Be Charged – The CDC negotiated a deal with vaccine providers that requires them to accept whatever insurance covers as payment, [Gov. Murphy said](#). And people without insurance would not be charged, he said. ([nj.com](#))

Newark Schools Push Back In-Person Instruction to April – Newark Public Schools, the state’s largest school district, announced Wednesday that students would [continue with remote classes until April 12](#) due to the pandemic. Students had been scheduled to begin returning to in-person classes on Jan. 25. ([nj.com](#))

Weekly Unemployment Claims Keep Rising – More than 1.9 million New Jersey workers have applied for unemployment insurance since the start of the pandemic, and [new claims have risen for five straight weeks](#), the state Department of Labor said. ([nj.com](#))

Police Officer Killed at Capitol Was From New Jersey – The police officer killed when a violent mob of President Donald Trump supporters stormed the U.S. Capitol on Wednesday is a New Jersey native, Gov. Murphy said. [Brian D. Sicknick, 42, was a graduate of Middlesex County Vocational Technical High School’s East Brunswick Campus and grew up in South River](#), the governor said Friday. Gov. Murphy Deploys 500 Members of New Jersey’s National Guard to D.C. – The deployment will likely last through at least the inauguration on Jan. 20, Murphy said. The [500 members of the Guard will supplement the 74 New Jersey State Police troopers who were sent to Washington on Wednesday](#). (Politico)

Inauguration Day Will be Sunny – Joe Biden will be [sworn in as president at noon on Jan. 20](#). Most of the events will be conducted remotely. Biden will walk one block along Pennsylvania Avenue from 15th Street to the White House with a socially distanced presidential escort, featuring every branch of the U.S. Armed Forces. The long-range forecast calls for the weather to be sunny and 40 degrees. ([nj.com](#))
