The following guidelines have been set by the Orange Chamber of Commerce Citizens of the Year Selection Committee:

- A. The recipient must live, work, or provide service in City of Orange.
- B. Service to the Orange community includes charitable and other outstanding service, as well as humanitarian acts or heroism. The recipient must be an active participant in boards and organizations and not just a member.
- C. Meritorious service can be within the last year or over a span of years.
- D. Recognition will be given for leadership and performance for work done above and beyond his/her paid profession. Current Elected officials, Chamber Board Members and staff are not eligible.
- E. Nominations can come from individuals or organizations.
- F. One to four letters in support of the nominee are requested, and must be submitted with the nomination form.
- G. **Please include a 4x6 (or larger) picture of the nominee.** This picture will be used for press purposes.

2018 ORANGE CITIZEN OF THE YEAR

Selection Criteria & Guidelines

1. The Citizen of the Year award, sponsored by the Orange Chamber of Commerce, celebrates an individual who has unselfishly given to the community and who has created a more dignified, unique place in which we all work and live.
2. The nominee should have participated in a broad scope of activities over the course of more than one year. This is not an award for a single activity, no matter how well it was executed. The recipient must be an active participant in boards and organizations and not just a member.
3. Selection of the individual who best exemplifies the ideals of the Citizen of the Year.
4. In order to be considered by the committee as a nominee for the Citizen of the Year, the sponsoring organization must submit an official nomination form with supporting documentation in a timely manner.
5. Consideration will be given to individual nominations by the committee. In exceptional cases, where the applications of the nominee involve individuals who have been full, complete partners in all their efforts in the community, a joint nomination will be accepted by the committee.
6. Current elected officials, Orange Chamber of Commerce Board members and staff are not eligible.
7. Committee members are responsible to promote the nominations from organizations in the community; however, they do not propose, support or process applications.
8. The Orange Chamber of Commerce Board of Directors will make the final selection, based on recommendation of the Citizen of the Year committee, which is made up of all past Citizens of the Year who are willing and want to serve.
