

DCNR & WPC Watershed Forestry – Lawn Conversion PLUS Program **Funding Contract**

Administered by the Western Pennsylvania Conservancy

Please review, sign, and return this contract to **Kelsey Miller** at the address below along with a copy of the **Project Application, signed Landowner Agreement, Planting Plan, Map and PLUS fund request** (if applicable). Upon receipt of this signed contract and email approval notice from DCNR, your project will begin and funding will be dispersed to your organization.

Lawn Conversion Program Funding Recipient Responsibilities:

The recipient of Lawn Conversion Program funds must provide the following to receive funds:

- Provide the signed **Landowner Agreement** between the landowner of the site where the tree planting is to be installed and the Implementation Partner;
- Provide an **establishment plan** for the site, approved by DCNR.
- Agree to install acres of upland tree planting and acres of meadow planting on project named: _____;
- Agree to manage all aspects of the installation of the tree planting and meadow;
- **Complete and submit a post-planting report within 60 days of the planting date to Kelsey Miller**, that includes a final map of planted acres, one to three site reference photos, and a list of species planted (for meadows, include a copy of the seed mix tag);
- Ensure upland tree and meadow planting maintenance is upheld for the duration of the five-year **Landowner Agreement**.

Project failure due to improper site preparation and planting/seeding will result in partners no longer being eligible for future funding through this or related funding opportunities.

Western Pennsylvania Conservancy Responsibilities

As the administrator of the funding, WPC will provide a pre-planting **award of \$ for the planting of acres of upland trees and acres of meadow to the Implementation Partner** upon receipt of this signed contract.

In providing this funding, WPC assumes no obligation to provide further funding or support to the funding recipient (Implementation Partner) beyond the terms stated in this contract.



Amendments
