

Dear Nurse Practitioner Educator,

You are invited to participate in the research study entitled, "Perceived Effectiveness of Nursing Faculty of Clinical Video Simulation for Use in Nurse Practitioner Education". This study is being conducted by my research team at the University of North Carolina at Greensboro (UNCG) School of Nursing. We are seeking nurse practitioner faculty members to provide feedback on the videos found here at this website: [UNCG HRSA Videos](#). You will be asked to provide collective feedback on videos that you have incorporated into the nurse practitioner curriculum.

If you are willing to participate, we will ask you to complete an on-line [survey](#) and provide some general information on the nurse practitioner program in which you teach. **You will not provide your name or other such specific information that can link your identity to the survey.** The survey includes 1 item asking you to identify as a nurse practitioner faculty member, 1 item about the type of educational program(s) that you teach, 1 item that pertains to the state or country that you are employed, 1 item that pertains to your employment status as full time or part time, a listing of 23 videos that you may incorporate in your nurse practitioner curriculum, 3 items pertaining to the use of the video and the type of course structure, and 18 items about perceived effectiveness of the clinical video simulations. Participants will rate their responses to these 18 items using a 5-point scale ranging from strongly agree (5) to strongly disagree (1).

Participation in the survey is expected to take no more than 20 minutes of your time. Your participation in the study is entirely voluntary and there is no penalty if you do not participate. Your decision to participate or not participate will not be communicated to your employer, nor will it affect your employment in any way. **Your participation is anonymous.** You may withdraw from the study at any time. Absolute confidentiality of data provided through the Internet cannot be guaranteed due to the limited protections of Internet access. If you do participate in the [survey](#), please be sure to close your browser when finished so no one will be able to see what you have been doing.

At the conclusion of the study, all electronic data files will be copied to the UNCG secured server space. Any paper data related to the study will be stored in a locked file cabinet in the locked UNCG office of the Principal Investigator (PI) accessible only by the PI/research team. All data will be kept for 5 years and then destroyed.

This research study has been reviewed by the UNCG Institutional Review Board.
