It is my hope that the Consensus Model that shapes licensure, accreditation, certification and education of advanced practice nurses will delineate gerontology as a population foci. Currently, gerontology is combined with adult health; there are no minimum geriatric didactic or clinical hours and faculty are not required to have gerontology experience.

Be active in professional organizations, attend gerontological conferences, and model a passion for delivery of competent, evidence based care to older adults.
