Jr. Miss Litchfield Chamber of Commerce Pageant 2021 Rules

- 1. Each entrant must be enrolled in a Litchfield public or private school, or home-schooled, and be 11 to 15 years of age on or before August 31st.**
- 2. Entrants must be of good moral character and, if selected as Jr. Miss Litchfield Chamber of Commerce, will refrain from conduct deemed detrimental to the Litchfield Chamber of Commerce as determined solely by the Board of Directors of the Litchfield Chamber of Commerce.**
- 3. All decisions as to the entrant's eligibility or removal after selection as Jr. Miss Litchfield Chamber of Commerce for conduct deemed detrimental to the Litchfield Chamber of Commerce shall be determined by the Board of Directors of the Litchfield Chamber of Commerce.**
- 4. All decisions of the pageant judges are final and non-appealable.**
- 5. Any entrant and/or family member or guest showing unsportsmanlike behavior will lead to the disqualification of the entrant as determined by the pageant judges or the Board of Directors of the Litchfield Chamber of Commerce. No refunds will be given.**
- 6. Recipient of the title "Jr. Miss Litchfield Chamber of Commerce" promises to promote the program by attending a minimum of 80 percent of Litchfield Chamber of Commerce events requiring a personal appearance if asked during her reign, which shall begin with her crowning as Jr. Miss Litchfield Chamber of Commerce and end upon the crowning of her successor or upon her resignation or removal as Jr. Miss Litchfield Chamber of Commerce, whichever occurs first.**
- 7. Entrants must attend at least 80 percent of dance practices. If absent, a written excuse must be submitted to the dance instructor or the pageant chairperson. Failure to comply may result in eviction from the pageant.**
- 8. Jr. Miss Litchfield Chamber of Commerce promises to return to the next year's Jr. Miss Litchfield Chamber of Commerce Pageant as the reigning Jr. Miss Litchfield Chamber of Commerce, in crown and sash, to crown her successor.**
