RULES

ARTISTS AND SPONSORS

1. Designs must reflect the Festival theme of "A STROLL DOWN MEMORY LANE."
2. Only family-friendly (G-rated) designs will be allowed.
3. Artists must provide their own materials; they will receive a \$20 stipend to offset the cost of their materials. Artists may bring their own chairs, as none will be provided.
4. All artwork must be produced on a background piece (canvas, foam core, wood, metal, plastic, fabric, etc.) no larger than 30" x 40" in size upon which they will create their artwork. Backgrounds will be placed on a standard, free-standing easel (provided), and can be oriented in either portrait or landscape configurations. No sculptures, crafts, or other creations will be allowed.
5. All artwork will be entered in a Silent Auction and will be created as a donation to the Litchfield Chamber of Commerce for inclusion in a Silent Auction. All proceeds from the Silent Auction will go to the Chamber to assist with future events, administration, etc. Each piece of artwork will become the property of the highest bidder. Any unsold artwork will become the property of the artist.
6. Only the registered artist may work on a piece of artwork.
7. Artists may begin work on their pieces anytime between 9 a.m. and 3:30 p.m. No work shall be done on any artwork pieces prior to the 9 a.m. start time. Judging will begin at 4 p.m., conducted by three specially selected judges.
8. Artwork and Silent Auction winners will be announced at 5:30 p.m. Artists do not need to be present to win. Silent Auction winners must remove their artwork prior to 6 p.m.
9. Sponsors may display brochures, products, other information, etc., at their table. Chairs will not be provided.
10. No pop-up shelters are allowed.

VISITORS

1. All alcoholic beverages must be purchased and consumed within the fenced-in, single entrance/exit Refreshments Lounge area, which will open at noon. Patrons cannot leave that area with alcoholic beverages. Visitors may not bring alcoholic beverages onto the Festival grounds.
2. Children 3 to 12 years of age will have access to the free Children's Creative Corner (C3) from 11 a.m. to 5 p.m., where they can create artwork of their own. This area will be supervised by a licensed child care professional assisted by volunteers. The C3 will accommodate children on a first come/first served basis. No child can remain in the C3 for more than 90 minutes. Parents or guardians will be required to provide a cell phone number and contact information before leaving their child or children at the C3. They will be given a ticket that must be presented to the C3 supervisor upon their return before their child/children will be released to them.
3. In the event of inclement weather, the Festival will be held at a future date to be determined.
