

Frequently Asked Questions

When are my property taxes due?

Payments may be paid in two equal installments, for the amounts indicated on your tax notice, or in one full installment. Partial payments and postdated checks are not accepted.

First Half: February 28th

Second Half: June 15th

Full Payment: April 30th

What method of payment do you accept?

- Cash
- Checks
- E-Checks
- Credit Cards
- Certified Funds
- Money Orders

Are postmarks accepted?

For current year taxes, payments bearing a U.S. Postal Service postmark reflective of the above due dates are acceptable

If the due date falls on a Friday, Weekend or a legal holiday a postmark for the following business day will be accepted

If your payment is postmarked after the due date, delinquent interest is added to the tax amount.

What if my taxes are paid by my mortgage company?

Property tax statements are mailed to the owner of record as their name and address are listed on the Tax Roll. Most mortgage companies request payment information directly from the Treasurer's office.

What if my mailing address changes?

You are responsible for notifying the Treasurer's Office of your address change. Changes can be submitted by phone, mail or online.

How to Make an Online Payment

- Go to the Ouray County website at www.ouraycounty.gov
- Click on the **How Do I...** link at the top of the home page
- Under **Pay** click on **Pay Your Bill On-Line**, this will take you to the on-line payment portal
- Click **Agree** and then click on the **Find Your Bill** button under **Tax Office**
- Enter one of the following: Account Number, Last name or Property Address (less is more)
- Choose to pay the 1st, 2nd or both installments and click **Add**
- Once payment has been added to **Your Cart** you can choose your payment option
Credit cards: 2.40% fee
E-Checks : \$1.50 fee
- You have the option to create an account. This will save your information for future payments and give you the option to setup auto-pay

Step 1: Find a Bill

SEARCH BY PARCEL NUMBER, NAME, ADDRESS

You can locate any property in our database by entering your search in the box above. We recommend excluding any dashes or spaces.

OWNER NAME OR ADDRESS

If you do not know your parcel, you can try searching by Owner Name or Street Address. We recommend excluding any punctuation.

Step 2: Pay for a Bill

Once you locate your property using the search methods above, simply click the 'Add' button to the left of the property to add it to your cart. If multiple installments are supported, you can also select which installment(s) that you would like to include in your payment.

VIEW CART

This step allows you to review the bill(s) that you selected to pay. You can make changes by removing or modifying the installment(s) you'd like to include.

CREATE AN ACCOUNT

This step allows you to create an account and enter your billing information.

ENTER YOUR PAYMENT INFORMATION

This step allows you to enter your payment details and is the final step before your payment is applied.
