If you are flying out of a different airport, there may be other options, but essentially a direct flight to St. Kitts is usually once a week. Before you book your flight...

There are two airport options:

1. Fly to Puerto Rico and take Seaborne Airlines directly into the small airport in Nevis where the Four Seasons car service will bring you to the hotel.
2. Fly into St. Kitts where a van will take you to the harbor for the 15-minute boat ride directly to the Four Seasons (most popular).

If you would like to stay until Saturday, March 23rd in order to take advantage of the direct flights, there are many options!
