LPGA AMATEUR GOLF ASSOCIATION RELEASE AND INDEMNIFICATION AGREEMENT

Upon submission of this application, the Member ("Member") agrees to be bound by the following conditions, terms and release, in connection with Member's participation in activities and/or events organized or sponsored by Chapters of the LPGA Amateur Golf Association ("LAGA") (individually and collectively, an "Event"), whether Member's participation is golf-related or social in nature. Member understands that the LAGA program ("LAGA Program") is a program of LPGA Foundation, Inc. (the "LPGA Foundation") and that the LPGA Foundation is a licensee of Ladies Professional Golf Association, Inc. (the "LPGA").

Member understands that golf is a sport requiring physical exertion, and may involve other individuals, flying projectiles, motorized vehicles and other unknown, unanticipated or unpredicted risks and/or hazards, that Member may be exposed to the risks of serious injury, permanent disability, or even death. Member is fully aware of, and assumes, these risks. Member understands that the Chapter may or may not provide the Member with any assistance, guidance or training in the sport or the rules of the game and/or golf course being played, but that the Chapter providing such (or not doing so) in no way affects, alters or modifies the terms Member is agreeing to herein.

Member recognizes that the Chapter cannot control the conditions of the golf course; nor control the conduct of other individuals playing at the golf course or employees/staff on the golf course, or any other individuals (including other Event participants) or uninvited guests; nor otherwise reduce any risk to which Member may be subject during any time period Member is playing golf. Member acknowledges and recognizes that Member's participation in the Event is voluntary and undertaken by Member at Member's own choosing and with a full understanding and awareness of the risks that it poses to Member and to others. Member also certifies that Member is in adequate physical condition and fully capable of playing the game and undertaking any tasks that Member chooses to perform.

Release. MEMBER ASSUMES ALL RISK AND DANGER SURROUNDING AND ASSOCIATED WITH MEMBER'S PARTICIPATION IN EVENTS, from known, unknown, obvious and hidden conditions, including, without limitation, being struck by misdirected golf balls or carts, falls on and/or around the Event golf course and surrounding areas, and actions of third parties, whether such risk or danger occurs prior to, during, or subsequent thereto. In consideration for allowing Member to participate as a participant and all other benefits to Member arising therefrom, Member, Member's personal representatives and administrators, heirs, and next of kin hereby waive, release, covenant not to sue, and forever discharge the Event, Chapter, the LPGA Foundation, LPGA, the host facility and golf club, all sponsors and/or third parties involved in the Event, and each of their respective affiliates, officers, directors, employees, volunteers, sponsors, workers, members and agents (collectively, "Releasees") from and against any and all injuries, losses, damages, claims, actions, and any liability of any kind (including, without limitation, personal injury, death, or loss or damage to personal, private, or other property), whether caused by the negligence of Releasees or otherwise, as a result of or in connection with Member's participation in and/or presence at the Event. Member further agrees to indemnify, defend and hold harmless the Releasees for any liability, demand, judgment, claim or suit, including reasonable costs and attorney fees, arising out of or in connection with Member's acts or omissions or allegations thereof as a participant in the Event and/or while Member is on the Event property. Member will be responsible for Member's personal belongings and equipment and will not hold Releasees responsible for their loss. Member will treat the facilities and equipment provided in connection with the Event with care and Member understands Member will be assessed for any damage to facilities or equipment caused by Member's acts or omissions.

Media Rights/Likeness. Member hereby grants permission throughout the universe in perpetuity to Releasees to utilize Member's likeness, image, voice, and/or words incidental to any pictures, television, radio, videotapes, recordings, film, the Internet, or any other form or medium now known or hereinafter devised without compensation, payment royalties, notification, or permission. Member further understands and irrevocably agrees that (i) these materials will become the property of Releasees and will not be returned to Member; (ii) Releasees may edit, alter, copy, exhibit, publish or distribute photos for purposes of publicizing or promoting Releasees, its programs, or for any other lawful purpose; and (iii) Member waives any right to inspect or approve Releasees' use of Member's likeness, image, voice, and/or words.

First Aid. In the event that Member is unable to do so on Member's own because of injury or illness, Member consents to administration of first aid and/or medical treatment, and agrees to indemnify, waive, release, covenant not to sue, and forever discharge Releasees from any and all liability or claims arising out of such treatment.

Non-Solicitation. LAGA has a very strict policy on the use of any and all member and Chapter contact information. This applies to information on the LAGA website and on its Chapter websites and includes generic Chapter email addresses, member information and Chapter volunteer contact information.

All LAGA contact information is intellectual property of the LPGA Foundation and is to be used only with permission by the LPGA Foundation, LAGA Headquarters, or by its Chapters for conducting LAGA business or by LAGA sponsors/partners according to contractual agreement. All generic Chapter email addresses on LAGA or Chapter websites are intended for personal use by LAGA members wishing to connect with other members and for non-members wishing to learn more about LAGA.

Miscellaneous. Member acknowledges that the terms of this document may be modified at any time to impose new or additional terms or conditions related to participation in the Event. Such modifications and additional terms and conditions will be effective immediately and Member's continued participation in Event will be deemed acceptance thereof. Member agrees that Florida law shall govern any and all disputes arising in connection with participation in the Event, receipt of services described in connection therewith, and disputes involving Releasees. Such disputes shall be resolved by arbitration in the State of Florida pursuant to the Commercial Rules of the American Arbitration Association then in force. A judgment upon the award rendered by the arbitrators shall be final and non-appealable and may be entered in any court having jurisdiction thereof.
