

### 2023 Legislative Session Weekly Report Greater Kitsap Chamber of Commerce March 19, 2023

#### Week Ten

As week 10 comes to a close, we now have less than 40 days remaining in the legislative session. This week legislators returned to their respective committees in order to hear bills from the opposite chamber. Bills must now move forward in the opposite chamber, progressing through policy and fiscal committees. The opposite house fiscal cutoff is April 4th, and then both chambers will return to the floor to debate bills before the opposite floor cutoff on April 12th.

Following the house of origin cutoff last week, both Democrats and Republicans gave their perspectives on how things went. Senators Billig and Randall were joined by Representatives Jinkins and Fitzgibbon for the <a href="Democratic Leadership Media Availability">Democratic Leadership Media Availability</a>. Senate Democrats voiced that they were proud of the agreement that came together with the Blake decision and vehicular pursuits. During the <a href="Republican Leadership Media Availability">Republican Leadership Media Availability</a> on Tuesday, Senators Braun and Rivers were joined by Representatives Wilcox and Stokesbary. Republican leadership voiced appreciation for the passage of the Blake decision, vehicular pursuits, middle housing, ADU legislation, and educational bills that work on learning loss.

There are many labor and workforce bills that are making their way through the legislature still. On Monday, the Senate Labor and Commerce Committee heard HB 1050 (Riccelli, D-3) which expands apprenticeship utilization requirements to state agencies, school districts, and 4-year projects that cost \$1 million or more. Also on Monday, the Senate Early Learning and K-12 Committee heard bipartisan HB 1525 (Fosse, D-38) which expands Working Connections Child Care eligibility to include the first 12 months of an applicant's enrollment in a state registered apprenticeship program. Supporters say those pursuing apprenticeships should have the same access to child care that students in vocational programs have. Apprenticeships have been a major area of interest for both parties in recent years as the legislature focuses on filling the worker shortage across various sectors. On Tuesday the House Labor and Workplace Standards Committee heard SB 5217 (Dhingra, D-45), which restores the state's ability to regulate certain industries and risk classes to prevent musculoskeletal injuries and disorders. On Friday the Committee passed the bill.

Environmental issues also continue to be a priority for the majority party with several bills heard this week. On Monday, the House Committee on Environment & Energy heard governor-request \$\frac{SB}{5165}\$ (Nguyen, D-34) which changes Washington's electric transmission planning timelines and requires planners to consider renewable energy projects. The bill passed the Senate floor 36-13. \$\frac{HB}{1181}\$ (Duerr, D-1) was heard in the Senate Committee on Local Government, Land Use & Tribal Affairs Committee on Tuesday. Among other elements, this governor-request bill will require climate change planning under the Growth Management Act. This bill received a lengthy debate and 14 proposed amendments over on the House floor with one Democrat joining Republicans in opposition, passing 57-41. The Senate Environment Energy and Technology Committee heard another piece of governor-request legislation this week \$\frac{HB}{1216}\$ (Fitzgibbon, D-34) which aims create more efficient siting of clean energy projects, protect the environment, communities, and tribes, as well as benefit communities that host clean

energy projects, and facilitate the transition to clean energy. The bill passed the House 75-20. <u>HB 1589</u> (Doglio, D-22) was heard for a public hearing in front of the Senate Committee on Environment, Energy & Technology on Friday. This bill works to decarbonize the electric utility grid by incentivizing a certain utility to move away from natural gas by June 30th of this year. Thirty-nine individuals testified on the legislation.

A couple of bills relating to public safety that worked their way through committees this week. <u>SB 5740</u> (J. Wilson, R-19), regarding catalytic converter theft, had a public hearing this week. <u>HB 1638</u> (Fey, D-27) which addresses state trooper recruitment had a public hearing on Monday. As of 2022, out of the 683 state patrol positions patrolling the roads, there were 187 vacancies. This bill helps create a monetary incentive program to help hire and retain peace officers.

Health insurance plans in Washington may cover additional items if two bills heard this week in the Senate Committee on Health & Long Term Care week pass. On Tuesday, the committee heard HB 1222 (Orwall, D-33) which requires non-grandfathered large group health plans to provide coverage for hearing instruments, modifies requirements for hearing instrument coverage for plans offered to public employees, and requires the insurance commissioner to include hearing instruments in any updated essential health benefits benchmark plan, upon authorization from the Legislature to update the plan. This bill was a bit of an anomaly in House Appropriations where the committee heard testimony from impacted children, went to caucus immediately, and gave it a bipartisan vote the same day, which is exceedingly rare. On the House floor, the bill received broad bipartisan support, passing 89-8. And on Thursday, the committee heard HB 1151 (Stonier, D-49) which would require large group health plans, including health plans offered to public employees, to cover the diagnosis of infertility, treatment for infertility, and standard fertility preservation services. This bill passed the House 65-30, with Republican lawmakers expressing concern about the rising cost of premiums

On Thursday, the House headed to the floor to take action on several tax related bills. These bills are considered necessary to implement the budget (NTIB) and hence, they are not subject to cutoffs.. One of the bills that passed unanimously was <a href="HB 1018">HB 1018</a> (Tharinger, D-24), which aims to change the expiration date for the sales and use tax exemption of hog fuel to comply with the 2045 deadline for fossil fuel-free electrical generation in Washington state. This bill also intends to protect jobs with health care and retirement benefits in economically distressed communities. <a href="HB 1573">HB 1573</a> (Rule, D-42) drew some opposition for proposing the extension of B&O tax preferences for dairy, fruit and vegetable, and seafood processors from 2025 to 2035. The bill eventually passed with a vote of 77-19.

On Friday, the Senate Housing Committee held hearings on two high profile pieces of legislation related to housing. First on the agenda was <u>HB 1474</u> (Taylor, D-30) which creates the Covenant Homeownership Account to assist individuals that were affected by racially restrictive covenants with first-time home purchasing costs. The bill passed the House 53-43. Second on the agenda was <u>HB 1110</u> (Bateman, D-20) which is legislation that addresses the "missing middle" by requiring cities to change local zoning laws to allow for more dense housing. Rep. Bateman (D-20) and republican co-sponsor Rep. Barkis (R-2) presented the bill together to the Senate Housing Committee, demonstrating that there is bipartisan support for the legislation. Over 40 individuals testified on the bill.

Next week, the House and Senate will continue to hear and pass bills that have passed out of the opposite chamber. The focus will also shift to budget conversations as the state revenue forecast is expected to come out on Monday, and the Washington State Economic and Revenue Forecast Council update will begin at 2:00 PM. <u>Tune in here</u> to get the latest update. We expect that the Senate will release their Capital, Operating and Transportation next week and the House will release theirs soon after. At that time budget negotiations will begin.

## <u>HB 1351/SB 5456</u> - Prohibiting the imposition of minimum parking requirements except under certain circumstances.

This bill was introduced to encourage more transit oriented development by prohibiting minimum parking requirements. Specifically, this bill would prohibit cities and counties planning under the Growth Management Act from imposing minimum parking requirements within certain distances of transit stops in order to allow areas well-served by transit to add more housing and business opportunities. The House bill remains in Rules and is unlikely to move forward this session.

#### HB 1245/SB 5364 - Increasing housing options through lot splitting

The bill requires cities planning under the Growth Management Act to incorporate certain lot splitting regulations into their development regulations, zoning regulations, and other official controls. The House bill passed this week 94-2. HB 1245 was heard in the Senate Local Government, Land Use and Tribal Affairs Committee on Tuesday, March 14th and executive action is scheduled for Wednesday, March 23rd.

## $\underline{HB~1181}/\underline{SB~5203}$ - Improving the state's response to climate change by updating the state's planning framework

This legislation updates existing goals of the Growth Management Act (GMA) and adds a climate change and resiliency goal and adds a climate change and resiliency element to the list of elements that must be included within the comprehensive plans that certain counties and cities must adopt under the GMA. This week the bill passed the House 57-41. HB 1181 was heard in the Senate Local Government, Land Use and Tribal Affairs Committee on Tuesday, March 14th and executive action was taken on Thursday, March 16th. The bill has been referred to the Ways and Means Committee.

Public Safety

#### HB 1363/SB 5352 - Concerning vehicular pursuits

Legislators are revisiting law enforcement reform legislation related to vehicular pursuits that was adopted in 2021. HB 1363/SB 5352 have been introduced with a long list of bipartisan sponsors. The bill as introduced would lower the evidentiary threshold required for engaging in a vehicular pursuit by allowing an officer to conduct the vehicular pursuit if the officer has reasonable suspicion that a person in the vehicle has committed or is committing any criminal offense The Senate made a motion to pull SB 5352 from the Senate Law and Justice Committee to the floor for a vote. The Senate adopted a <a href="striking amendment">striking amendment</a> offered by Senator Dhingra and the bill passed 26-23. The bill has been referred to the House Community Safety, Justice and Reentry Committee but has not yet been scheduled for a public hearing.

## <u>SB 5536</u> - Concerning controlled substances, counterfeit substances, and legend drug possession and treatment

This legislation sponsored by Senator Robinson is the vehicle for legislation dealing with the Blake decision this session. The bill increases the penalty for knowing possession of a controlled substance or counterfeit substance to a gross misdemeanor, creates a pretrial diversion program for individuals charged with possession of prohibited substances, and provides for vacating possession convictions contingent on the individual completing substance use disorder treatment. The Senate brought the bill to the floor for a lengthy floor debate. The body considered several amendments and ultimately passed the bill 28-21. 15 democrats voted against the bill along with 6 republicans. The split vote comes with different perspectives as it relates to criminalizing drug possession, the 15 democrats that voted against the bill expressed on the floor that they believe criminalizing drug possession keeps folks in poverty and leads to homelessness and even drug overdoses. The 6 republicans that voted no likely would prefer to see increased penalties (for example a felony) for drug possession. The bill is scheduled for a public hearing in the House Community Safety, Justice and Reentry Committee on Monday, March 20th.

#### HB 1638 - Creating a state trooper expedited recruitment incentive program

This legislation creates the State Trooper Expedited Recruitment Incentive Program and directs WSP to establish hiring procedures and an accelerating training program for lateral hires from other law enforcement agencies. The bill passed the House this week 94-1. The bill was heard in the Senate Transportation Committee on Monday, March 13th.

#### **Economic and Workforce Development**

## <u>HB 1258</u>/ <u>SB 5465</u> - Increasing tourism to Washington state through enhancement of the statewide tourism marketing account and changing necessary match requirements.

This legislation would implement multiple measures to expand tourism in Washington State, including increasing the revenue collected into the Statewide Tourism Marketing Account from \$3 to \$9 million per biennium. SHB 1258 was unanimously passed out of the House. The underlying bill proposed an increase of \$26 million per biennium so proponents of the bill are likely to advocate that the full funding be restored as the bill moves through the Senate. HB 1258 was heard on Tuesday, March 14th in the Senate Business, Financial Services, Gaming and Trade Committee and is scheduled for executive session on Tuesday, March 21st.

#### HB 1717/SB 5379 - Supporting innovation at associate development organizations.

This legislation requires the Department of Commerce to establish an annual competitive grant program to support and catalyze initiatives to foster innovation, sustainability, partnerships, and equity at associate development organizations. HB 1717 passed the House 90-6. The bill was heard on Tuesday, March 14th in the Senate Business, Financial Services, Gaming and Trade Committee and is scheduled for executive session on Tuesday, March 21st.

#### <u>SSB 5286</u> - Modifying the premium provisions of the paid family and medical leave program

This bipartisan legislation proposes changes to the Paid Family Medical Leave (PFML) program including adjusting the way premiums are calculated, raising the cap on premiums, and creating a reserve fund. The bill passed the Senate 48-0 on February 1st. The bill was heard in the House Labor and Workplace Standards Committee on <a href="Tuesday, March 14th">Tuesday, March 14th</a>, the committee took executive action on the bill on <a href="Friday, March 17th">Friday, March 17th</a>.

# <u>SB 5217</u> - Concerning the state's ability to regulate certain industries and risk classes to prevent musculoskeletal injuries and disorders.

This bill repeals the law prohibiting the Department of Labor and Industries from adopting rules related to ergonomics or musculoskeletal disorders. This week the bill was brought to the Senate. There was a striking amendment adopted on the floor and then 14 additional amendments considered. The body ultimately adopted two additional amendments and the bill passed 27-21. The bill was heard in the House Labor and Workplace Standards Committee on <a href="Tuesday, March 14th">Tuesday, March 14th</a>, the committee took executive action on the bill on <a href="Friday, March 17th">Friday, March 17th</a>.

#### **Environment**

#### HB 1505/SB 5447 - Promoting the alternative jet fuel industry in Washington

This session bipartisan legislation was introduced related to sustainable aviation fuels. The goal of the legislation is to promote in-state use and deployment of sustainable aviation fuels through tax incentives and other tools. The bill was heard in the House Environment & Energy Committee on Monday, March 13th at 1:30pm and is scheduled for executive session on Tuesday, March 21st.

#### HB 1216/SB 5380 - Concerning clean energy siting

This Governor request legislation would create an Interagency Clean Energy Siting Coordinating Council to be cochaired by the Department of Ecology and the Department of Commerce. The purpose of the council would be to expedite the permitting for clean energy projects. The bill would also establish a definition for clean energy projects "of statewide significance" and require SEPA review to be completed within two years. This legislation passed out of the House on Saturday, March 4th with a strong bipartisan vote. It will now head to the Senate for further consideration. HB 1216 was heard in the Senate Environment, Energy & Technology Committee on <a href="Wednesday">Wednesday</a>, <a href="Wednesday">March 15th</a>.

#### HB 1131/SB 5154 - WRAP Act

What was once known as the RENEW Act (SB 5697 last session) has been rebranded as the Washington Recycling and Packaging Act or WRAP Act. This session the WRAP Act is sponsored by Rep. Liz Berry (D-36, Seattle) and Senator Christine Rolfes (D-23, Bainbridge/Kitsap County). The WRAP Act has passed out of the House and Senate policy committees and were sent to fiscal committees for further consideration. HB 1131 was passed by the House Appropriations Committee. The Committee adopted a <u>proposed second substitute</u> version of the vill and then adopted one <u>additional amendment</u> related to packaging for products intended for animals regulated under FIFRA. You can view the full text of <u>2SHB 1131</u>. Last week the bill was pulled from Rules and placed on the House floor calendar. The WRAP act ran into stiff resistance from a variety of stakeholders and with a significant number of legislators and did not pass out of the House. At this point, it appears to be dead for this session. We will continue to monitor what may come from this but no matter what, conversations around recycling and how to manage recycling will continue.

#### <u>Healthcare</u>

#### **SB 5236** - Concerning hospital staffing standards

The Nurse Staffing legislation is back from last year. This version of the bill would require the Department of Labor and Industries to regulate and enforce hospital staffing committees, staffing plans, and minimum staffing standards. This week the Senate brought the bill to the floor and adopted a negotiated <a href="striker">striker</a> offered by Senator Mullet. The bill passed 35-13. The bill was heard in the House Labor and Workplace Standards Committee on <a href="Wednesday">Wednesday</a>, <a href="March 15th">March 15th</a> at 8:00am and is scheduled for executive session on Tuesday, March 21st.

# <u>SB 5241</u> - Concerning material changes to the operations and governance structure of participants in the healthcare marketplace.

This legislation modifies reporting requirements for mergers, acquisitions, or contracting affiliations between hospitals, hospital systems, or provider organizations and requires the attorney general to determine, through a public process, if the transaction would detrimentally affect the continued existence of accessible, affordable health care in the state for at least ten years after the transaction occurs. The legislation is sponsored by Senator Randall (D-26). Providers have expressed serious concerns with the legislation. The legislation remains in Rules and is unlikely to move forward this session.

#### **Housing Affordability and Homelessness**

## <u>HB 1149</u> / <u>SB 5202</u> - Reducing homelessness in Washington state through capital expenditures for programs that address housing insecurity

Governor Inslee has proposed the state raise \$4 billion to build affordable housing by issuing bonds outside the state's debt limit, which will require legislative and voter approval. The Senate bill passed out of the Senate Housing Committee and has been referred to the Senate ways and Means Committee but has yet to be scheduled for a hearing.

# $\underline{HB~1110}/\underline{SB~5190}$ - Increasing middle housing in areas traditional dedicated to single-family detached housing

This session the conversation surrounding housing supply and the "missing middle" has gained significant momentum. HB 1110/SB 5190 would require cities with a population of at least 6,000 or a city near an urban growth area with a population of more than 200,000 to increase density in residential areas typically dedicated to single-family detached housing. HB 1110 passed the House Monday evening with a strong bipartisan vote of 75-

2023 Legislative Session Weekly Report March 19, 2023 Page 5 of 24 21. The bill has been referred to the Senate Housing Committee and was heard on <u>Friday, March 17th</u>. HB 1110 is scheduled for executive session on Wednesday, March 22nd.

#### HB 1517/SB 5466 - Promoting transit-oriented development

Senator Liias and Representative Reed are sponsoring Governor Inslee's bill focused on transit-oriented development, seeking density of residential development near transit hubs and light rail stations. Last week SB 5466 passed the Senate 40-8. The bill has now been referred to the House Housing Committee. HB 5466 was heard in the House Housing Committee on <a href="https://doi.org/10.1016/j.com/">Thursday, March 16th</a> and is scheduled for executive session on Tuesday, March 21st.

## <u>HB 1337</u> - Expanding housing options by easing barriers to the construction and use of accessory dwelling units.

This legislation would require cities and counties to allow accessory dwelling units (ADUs) in urban growth areas (with some restrictions) and permit homeowners to convert garages into ADUs. The bill passed the House this week 81-15. The bill was heard in the Senate Local Government, Land Use & Tribal Affairs Committee on Thursday, March 16th and is scheduled for executive session on Thursday, March 23rd.

#### HB 1276/SB 5235 - Concerning accessory dwelling units.

This legislation would require cities and counties to allow ADUs but differs from HB 1337 in that it also allows homeowners to lease the ADUs as short term rentals. SB 5235 passed the Senate this week 42-6. The bill was heard in the House Housing Committee on Monday, March 13th and was scheduled for executive action on Thursday, March 16th however no action was taken on the bill.

#### **Taxes**

#### SB 5482 / HB 1644 - Margins Tax

In 2017, the Washington State Legislature established the Tax Structure Work Group, a bipartisan group of legislators tasked with restructuring the state's tax code to address issues that the current code poses. One of the workgroup recommendations was to replace the state's Business & Occupational tax with a modified tax of gross receipts of what is known as a Margins Tax. The current B&O tax is based on gross income, where most businesses do not receive a deduction. Under the new proposed structure, businesses would be taxed on their margin, calculated as gross income minus one of four deductions (chosen annually) - cost of goods sold, compensation paid, a fixed percentage of gross receipts (30%), or a flat amount (\$1 million). You can use the <a href="Tax Calculator">Tax Calculator</a> to see what your business would pay. SB 5482 was heard in the Senate Business, Financial Services, Gaming and Trade Committee. HB 1644 was on Monday, February 20th in the House Finance Committee.

<u>SHB 1628</u> - Increasing the supply of affordable housing by modifying the state and local real estate excise tax This legislation would modify the real estate excise tax (REET) to provide funding for housing support for individuals with developmental disabilities and expand funding for the Housing Trust Fund, the Affordable Housing for All account, and the Apple Health and Homes account. SHB 1628 had a public hearing in the House Finance Committee. The bill has yet to be scheduled for executive action however it is not subject to cutoffs.

#### **Transportation**

# <u>ESHB 1736</u> - Requiring the department of licensing to collect vehicle odometer readings at the time of original vehicle registration and registration renewal.

This legislation would require the Department of Licensing to collect motor vehicle odometer readings upon vehicle registration. Failure to provide mileage would not result in denial of vehicle registration or the issuance of any penalty. ESHB 1736 had a public hearing on March 13 in its Senate policy committee and has not yet been scheduled for executive action.

#### **HB 1791** - Studying the need for increased commercial aviation services

This legislation would replace the Commercial Aviation Coordinating Commission (CACC), which was tasked in 2019 with identifying locations for a new large airport in Western Washington, with a Commercial Aviation Coordinating Work Group. The new Work Group would evaluate the commercial aviation needs of Washington within the broader context of state transportation needs and the specific needs of Western Washington. It would also require the Work Group to investigate the expansion of existing aviation facilities and possible locations for new greenfield aviation facilities and report on the strengths and weaknesses of each site considered. This substitute was passed out of the House Transportation Committee on February 23. The House passed the bill 88-9 and it is scheduled for a public hearing in the Senate Transportation Committee on Tuesday, March 21st.

#### HB 1846 / SB 5760 - Addressing vessel procurement at the Washington state ferries

This legislation was introduced this week by both transportation chairs and it would suspend the "Build in Washington" program for the build of the first five new hybrid diesel-electric ferry vessels. This means that the state could contract with companies outside of the state of Washington to build these five vessels. Both bills are scheduled for public hearings on Monday, March 20th.

<u>SB 5550</u> - Addressing workforce development issues, including cultural issues, at the Washington state ferries. Senator Liias has sponsored legislation seeking to address the workforce issues at Washington state ferries. The bill passed the Senate last week (45-3), and was heard in the House Transportation Committee on <u>Wednesday, March 15th at 4pm</u>.

We continue to monitor the Gorst coalition effort to maintain funding for this project.
