- C. Be thoroughly conversant with American Sign Language**
- D. Attend at least one PSAD Biennial conference or one PSAD Chapter or Section meeting prior to the forthcoming PSAD Biennial conference.**

What can you contribute by joining the PSAD Officers/Board of Managers?

First time candidates will be required to submit to a **Criminal History Record Request (CHRR)** through the **Pennsylvania State Police (PSP)** prior to running for a position on the Board of Managers or Officers. The CHRR can be accessed at: <https://www.psp.pa.gov/pages/request-a-criminal-history-record.aspx> and click on SP4-164A. The \$8 is waived because you are a volunteer. Thank you!

The PSAD Board of Managers is volunteer position. Board members are expected to attend quarterly meetings in locations as selected from time to time. They are expected to serve on committees and perform duties as required/requested from the entire board. Failure to follow through with duties and committees may be grounds for dismissal from the PSAD Board of Managers by a three fourth vote of the entire board.

This application and the CHRR must be submitted 60 days prior to the start of the annual meeting for adequate review.

Failure to submit the application and CHRR in 60 days will automatically disqualify the candidate, whether applying for the first time or applying for consecutive terms. CHRR may be exempt for a candidate that is running for another term.
