

URGENT – FOOD RECALL

October 28, 2025

Dear Valued Customer,

This letter is to inform you that Moonlight Companies is voluntarily recalling select lots of California-grown conventional yellow and white peaches shipped between September 16, 2025 and October 18, 2025 because they have the potential to be contaminated with *Listeria monocytogenes*, an organism which can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Although healthy individuals may suffer only short-term symptoms such as high fever, severe headache, stiffness, nausea, abdominal pain and diarrhea, Listeria infection can cause miscarriages and stillbirths among pregnant women.

The recall is for select lots of California-grown conventional yellow and white peaches shipped to you on or after September 16, 2025. The products are packaged as Moonlight and private label brands (see photos). Individual pieces of fruit bear PLU stickers (see photos). We have attached a file that lists your impacted purchase orders.

This recall only applies to the fruit packed in the State of California. It does not include any fruit grown or packed in the state of Washington or any organic fruit.

No illnesses have been reported to date.

Please carry out the following actions:

- We ask that you **please check your inventory. If you have recalled products in inventory, do not distribute them.**
- If you may have further distributed the recalled foods, please identify your customers and notify them of this product recall. Your notification to your customers may be enhanced by including a copy of this recall notification letter.
- Finally, we would appreciate you completing the attached Recall Return Response Form at your earliest convenience and returning it to claims@moonlightcompanies.com

This recall should be carried out to the consumer level. Your assistance is appreciated and necessary to prevent consumer illness. This recall is being made with the knowledge of the Food and Drug Administration.

We apologize for the inconvenience and thank you for your assistance with this important matter. Food safety has always been our top priority as we want to provide safe and
