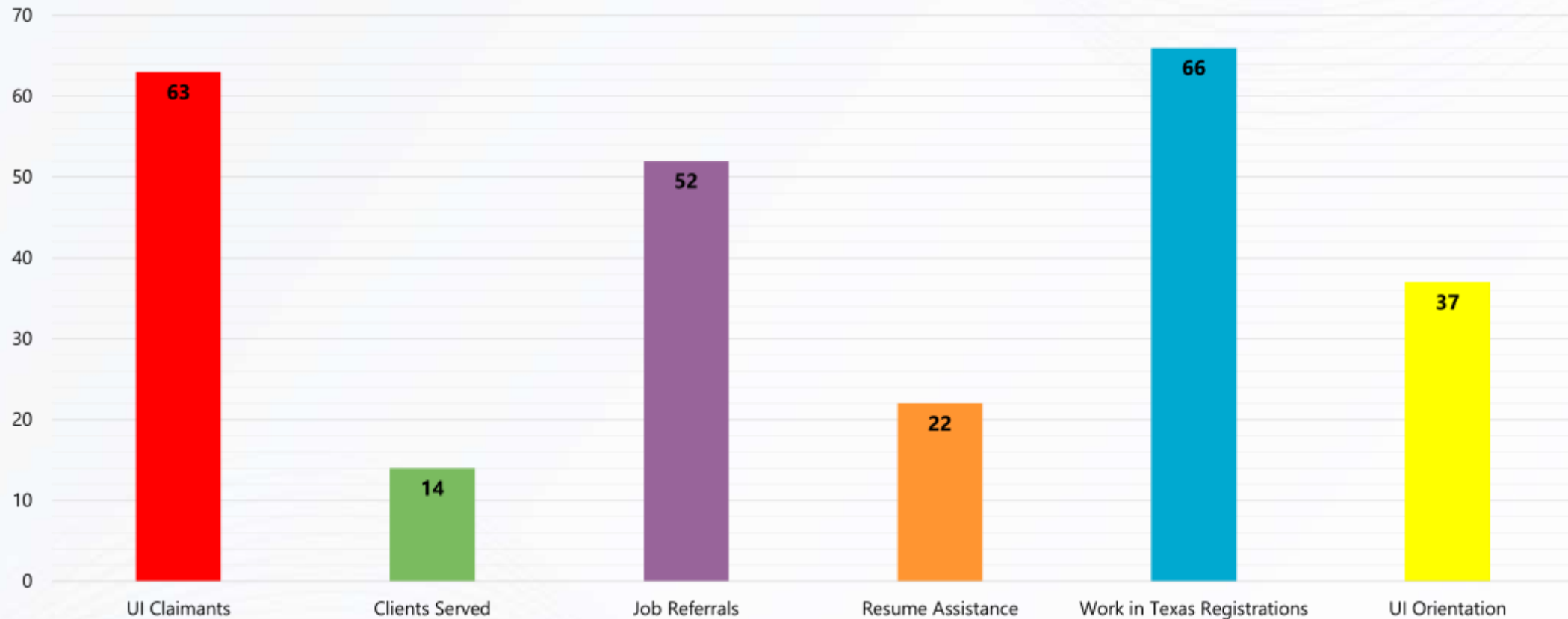

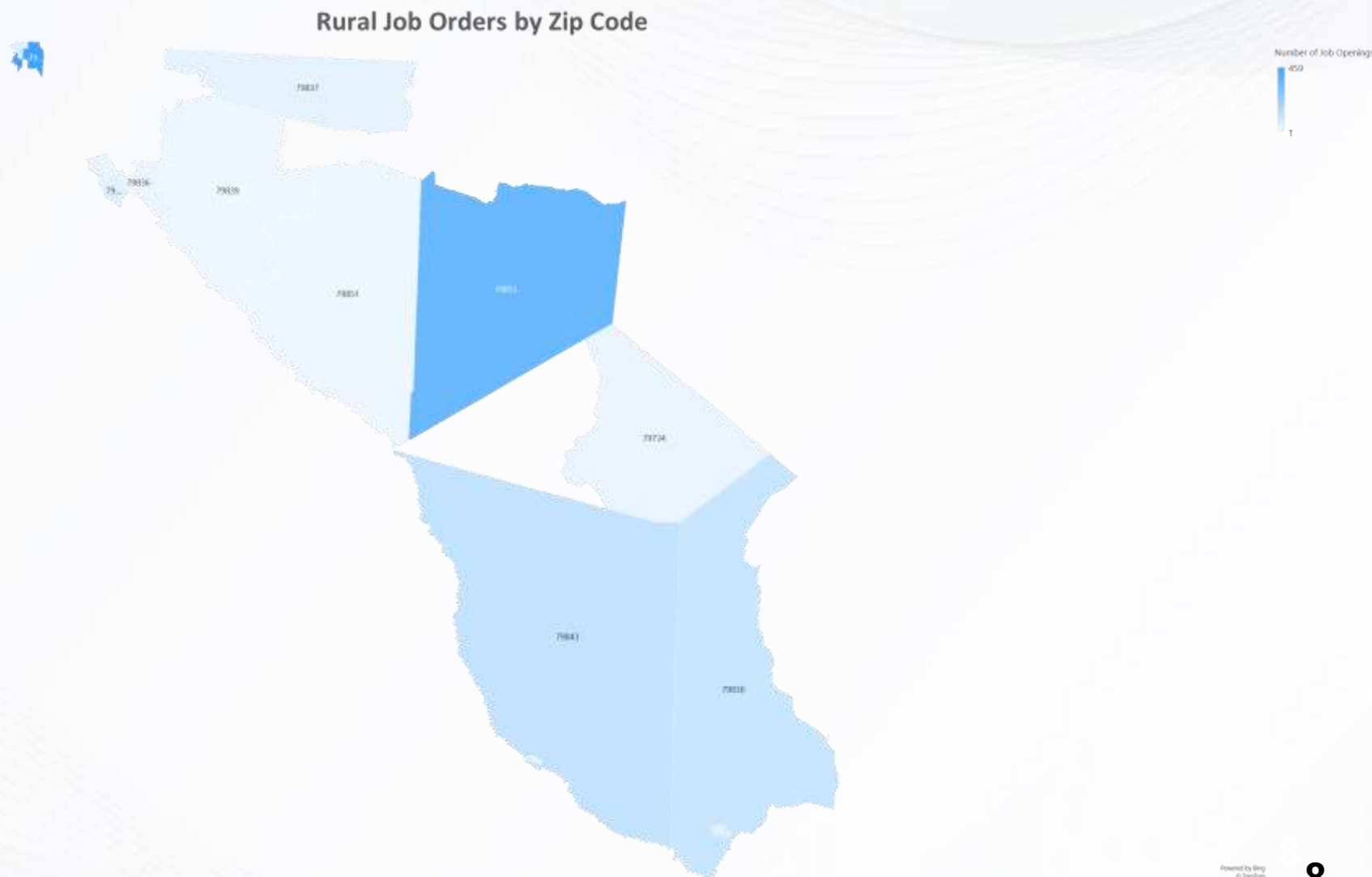

# Child Care Services- Brewster and Presidio County

- Alpine ISD has begun the process to move towards being licensed.  
Material and equipment set-up by mid July.  
Target date to operate is August 1, 2023.
- WSB applying for Childcare Investment Partnership (CCIP) to obtain additional funding with TWC for worker wage supplementation or stipends.  
\$500k total with match.
- One-time private fund to hire Presidio Outreach Specialist through RIOCOG, part-time until December 2023.
