## MINUTES

### 1. CALL TO ORDER AND NOTE OF ATTENDANCE

*(Dr. Armando Aguirre, Education and Youth Committee Chair)*

*Dr. Armando Aguirre, Education and Youth Committee Chair, called the meeting to order at 12:10 pm. Quorum was cited.*

### 2. ACTION ITEMS

**A:** Discussion and action to approve:

*(Marisela Correa, Family Services Director)*

*Motion (Gross/Maldonado) to approve the CCS Provider Paid Holidays and the CCS Provider Agreements. Motion carried 3-0.*

### 3. ACTIVITY REPORTS

**A:** Discussion and presentation on the study of after-hours childcare services commissioned by El Paso County. *(Alma Aranda, Workforce Development Director)*

*Ms. Alma Aranda, Workforce Development Director, presented the results of the El Paso County's International County Management Association Research Project study on the need and supply for after-hours child care services. There were 1,180 responses from parents, 85 responses from employers, and 115 from childcare providers. The study also included focus groups with child advocacy groups and the El Paso Police Department.*

**B:** Discussion to consider utilizing the Relative Care program as an incentive for workforce training and the consideration of limiting the amount of time a parent is eligible for the CCDF program. (*Marisela Correa, Family Services Director and Karina Castillo, Effectiveness and Research Director*)

*Ms. Marisela Correa, Family Services Director, discussed that 63 out of 4,927 parents utilize relative care; out of 310 child care contracted providers, 36 offer after-hours care.*

**C:** Discussion and updates on Child Care Services (*Marisela Correa, Family Services Director*)

Mr. Rogelio Luna, Project Specialist, discussed the college scholarships given to El Paso Community College students and the childcare industry support El Paso County ARPA Project.*
