**“SUPERMAJORITY” OF NYC COUNCIL CALLS ON GOVERNOR CUOMO,
MAYOR DE BLASIO TO DELAY TAX PAYMENTS TO HELP BUSINESSES
COPE WITH THE CORONAVIRUS CRISIS, “SOCIAL DISTANCING”**
*Request comes as Mayor de Blasio is Expected to Sign an Executive Order Limiting
Restaurants, Bars, Cafés to Take-out and Delivery; Order will Completely Close Other
Venues such as Theaters, Nightclubs and Concert Halls*

New York, NY – Amid the coronavirus pandemic and its devastating impact on local businesses, 38 members of the New York City Council have called on Governor Andrew Cuomo and Mayor Bill de Blasio to delay payments of a specific set of taxes to help struggling small businesses.

The members call attention to the impact that the pandemic is having on locally owned businesses, “In addition to the potential loss of life, the coronavirus crisis has impacted our city in ways that we are just now starting to comprehend. As advised by health officials, New Yorkers are “social distancing” themselves and avoiding gatherings in an effort to remain healthy and help contain the virus. This is good. Unfortunately, this is also having a tremendously negative impact on retail businesses and restaurants that depend on customer traffic to stay open and pay their employees. In some cases, businesses are reporting a drop-in sales that is as high as 50%.”

Specifically, the supermajority of the Council called on the two leaders to “temporarily delay the payments of specific state and municipal business taxes without penalties until our retail sector has had a chance to weather this unpredictable crisis. Specifically, in the next few months a slate of taxes will be due: business taxes on March 16th, sales taxes on March 20th and June 20th, payrolls taxes on April 30th and real estate taxes (including commercial rent tax and BID assessments) on July 1st.”

The request is being made as Mayor de Blasio is expected to sign an Executive Order which will further limit restaurants to take-out and delivery orders and completely close other venues such as theaters, nightclubs and concert halls.

Governor Cuomo and Mayor de Blasio:

Amid the ongoing crisis of the coronavirus pandemic, we the undersigned members of the New York City Council, call on you to delay the payment of a specific set of business taxes as locally owned businesses struggle to cope with an unprecedented loss in sales as customers avoid public venues.

New Yorkers are strong and resilient. Our city has been tested before and each time we have stood as an example of determination and tenacity. But today, like the rest of the world, we are being tested in a way like never before. In addition to the potential loss of life, the coronavirus crisis has impacted our city in ways that we are just now starting to comprehend. As advised by health officials, New Yorkers are “social distancing” themselves and avoiding gatherings in an effort to remain healthy and help contain the virus. This is good.

Unfortunately, this is also having a tremendously negative impact on retail businesses and restaurants that depend on customer traffic to stay open and pay their employees. In some cases, businesses are reporting a drop in sales that is as high as 50% - all while trying to meet payroll, pay government taxes and other expenses. This is an untenable situation.

Thus, we are calling on you to temporarily delay the payments of specific state and municipal business taxes without penalties until our retail sector has had a chance to weather this unpredictable crisis. Specifically, in the next few months a slate of taxes will be due: business taxes on March 16th, sales taxes on March 20th and June 20th, payrolls taxes on April 30th and real estate taxes (including commercial rent tax and BID assessments) on July 1st.

All levels of government must work together to provide struggling businesses with immediate relief so that they can keep cash on hand to meet their fixed costs and give them the ability to survive in this new reality. This crisis is happening in real time. Grants and loans that won't payout until the distant future may unfortunately be too late to save their business and the jobs that come with them.

In moments of crisis, leaders must be proactive and seek common sense solutions to seemingly immovable challenges. Paying taxes today and asking for loans and grants tomorrow defies logic.

Again, New Yorkers are strong and resilient. They only ask for fighting chance. Delaying the payment of key state and municipal business taxes will go a long way towards giving businesses, especially locally-owned mom-and-pop shops, the oxygen to weather this crisis.
