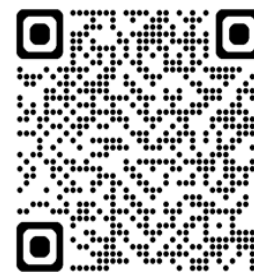

- 18) Did not join 17 State AGs seeking to prosecute Fauci at the state level for Covid mandates.

- 20) AG handed over personal Voter Data to the DOJ after they Sued Oklahoma, and he settled.
- 21) Gave disgraced State Rep. Ty Burns, only a misdemeanor, instead of a felony charge, after arrest for assault violence, attempted to gouge his wife's eyes out & run his own daughter off road.
- 22) Gentner dodged Eric Swalwell's question on Trump's 2 impeachments. He said: "That's outside my lane" - 1st impeachment, "I don't have an opinion" on 2nd impeachment. [See video](#)

- 26) Stitt said he was disappointed AG Gentner approved more than \$20,000 in taxpayer funds directed to Diversity Center of Oklahoma. Stitt said the Attorney General's approval came two weeks after he banned that type of funding in Executive Order 2023-31.
- 27) (Click) State Treasurer Todd Russ called Drummond out for trampling Constitutional boundaries & trying to centralize power. Russ hired attorney to help fight ESG, due to AG lack to help fight. Drummond responded by firing Russ' counsel over the ESG, appears Drummond close relations w/Blackrock.
- 28) Drummond and Russ were involved in another dispute involving (TSET) Tobacco Settlement Endowment Trust went to OK Supreme Court to fire AG as council & protest improper interference!
- 29) Drummond has positioned himself as a Key Opponent to Governor Kevin Stitt on several issues, including legal interpretations and policy disputes.

- 31) Former Cleveland County Sheriff Chris Amason, was indicted on four felony counts tied to campaign and taxpayer funds, moving thousands from his campaign to himself, & was using taxpayer money to send his wife to out of state conferences. He began his career as a special education teacher, then worked at Sand Springs for almost thirty years in teaching before joining Tulsa Tech. Most of his experience has been behind a desk, not in the classroom teaching. All of his statements, actions, are from Liberal Democrat view, openly promotes books like Christianity & HATE that attack the Christian Faith, conservatism, and the majority of conservative beliefs of Oklahoma.

- 1) Robert Hurt a Special Needs child, grabbing him by the ears with his hands, leaving deep scratch marks from his nails behind his ears/neck, and bruised ears lobes & face. 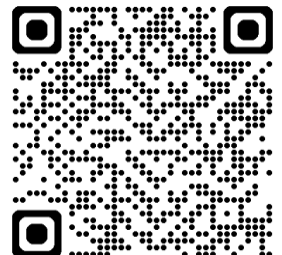

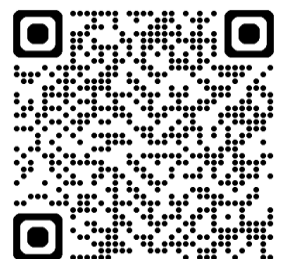
