Please note that the restricted information will remain available for the official use of the local Voter Registrar, the State, and political subdivisions of the State. See Tex. Att'y Gen. ORD-678 (2011). This form does not apply to information in the property tax appraisal records. To elect to restrict public access to certain property tax appraisal records, please complete and submit [HCAD Form 25.025](#) to the Harris County Appraisal District. This form does not apply to any document filed with the County Clerk or the District Clerk.
