On behalf of the 1700 Public, Educational and Government (PEG) Access organizations through the United States, we urge you to nominate a fifth Commissioner to the Federal Communications Commission.

Our organizations represent local governments, schools and school districts, colleges and non-profits in all 50 states and the US Virgin Islands that operate PEG channels on local cable systems and online providing vital community information and civic resources on a non-commercial basis to the public.

Over the course of the Covid-19 pandemic, our organizations have been front-line communicators, ensuring public health information is disseminated accurately to all residents in our communities. We have provided necessary educational assistance to teachers across America by providing classroom access to families without internet access. And we have helped to assure that local democracy is preserved during that crisis by enabling local governments to meet online and remotely with their constituents. Much of that work is documented in the American University report from August 2020 *PEG Access Media: Local Communication Hubs in a Pandemic*

It is vital that diverse and varied communities across the United States see these local media and information services continue and be strengthened in coming years – especially with the threat to local journalism that has been so well documented.

We urge you to act to ensure that takes place by forwarding a nomination to the US Senate to fill the vacant seat.
