COVID-19 Resources – Continuums of Care/Case Managers

[COVID-19 Guidance for Support Housing Providers](#)

This webpage, created by CSH, provides guidance for supportive housing providers and case managers. The page covers measures to keep staff and tenants safe during home visits, identifying staff to conduct home visits, questions to ask prior to a home visit, protocols for case managers while in a home, steps to take if a client shows symptoms, how to help clients prepare for COVID-19, implementing telephonic services, staff training, and special considerations when working with congregate programs.

[Questions for CoCs and Shelters to ask when preparing for COVID-19](#)

This webpage provides a list of questions, which can be used to prompt discussion and preparation for COVID-19 with-in shelters. This only provides questions to consider, it does not provide answers.

Questions include:

- Who will provide training and education on infectious disease for shelter staff?
- In the event that a shelter resident or unsheltered person tests positive for Coronavirus, is there a medical respite care program or medical shelter where they should be sent?
- What precautions can homeless program workers take to keep themselves safe? Do these precautions differ for street outreach workers?

This is a comprehensive tool kit, created by HUD to help CoCs prevent and manage the spread of infectious disease within shelters. The toolkit covers creation of sanitation guidelines; enforcing sanitation guidelines; guidance for frontline staff; and sample checklists for sanitation, cleaning, and food safety.

[Interim guidance for homeless service providers to plan and respond to coronavirus disease 2019](#)

This guide, created and updated by the CDC, covers suggested early actions to slow the spread of COVID-19 to keep staff and clients healthy. Suggestions consider emergency operations, communication plans, information sharing, sanitization, and screening. The guide also shares suggested steps for follow-up, once the outbreak has slowed or ended.

This includes detailed information on disinfecting multiple types of surfaces, use of personal protective equipment (PPE), hand hygiene, and additional considerations.

This document provides guidance focused on steps that should be taken to better protect the health and well-being of people who will remain unsheltered during the COVID-19 outbreak. This includes recommendations for sanitation, access to food and water, and service coordination. It is important to note: this document stresses the importance that ***encampments should not be cleared*** during COVID-19, unless access to individual units and rooms will be made available.
