Online Standards Training September 9 to September 20, 2021

- The Online portion of the training is your opportunity to become familiar with the 2020 version of the CET Standards including Level 1, Level 2, Children, CSND and our newest addition which is the Secure Treatment standards.
- This is Self-Directed training that is available on the ACDS learning management platform, Moodle.
- You will need to have a score of 80% or higher on an evaluation quiz after reviewing the content to proceed with the virtual portion of the training. The Online Training will be available September 9 and must be completed by September 20. The quiz component will be due by 4:00pm on September 20.
- Online training is mandatory for all current surveyors in order to continue surveying under the new CET Framework and standards.

FAQ

Q: *When will the new standards be in effect?*

A: The 2020 standards will officially come into effect April 2022. Beginning September 2021, service providers can choose which standards to go through. The first survey under the new standards is currently scheduled for November 2021

Q: *Will there be another opportunity to take Surveyor Training if I can't make this one work with my schedule?*

A: The online component is where you have the *ongoing* opportunity to learn about the requirements of the new standards as either a surveyor or a service provider. The virtual portion will be recorded for those unable to attend, however we will be conducting virtual training twice a year at minimum.

Q: *If I take the final report training, do I have to commit to becoming a CET Team Leader?*

A: No. We would like to encourage more people to pursue Accreditation Team Leading; however, it is also good information to understand how the information is gathered and compiled into the final report and what evidence and examples are needed from the surveyors in order to speak to each of the indicators thoroughly.
