



## TRWA 2021 Calendar Contest Guidelines and Entry Form

The Taunton River Watershed Alliance (TRWA) is pleased to announce a calendar contest for their 2021 Annual calendar. It is open to **all**, amateur and professional, young and old. Photographs must be of wild life, scenery, or recreational activities **TAKEN WITHIN the Taunton River Watershed** related to water use and conservation within the watershed. Photographs must be *taken within the last five years* and must be the sole property of the submitting party. Please see map on the other side of this sheet for a listing of towns that are within the watershed.

### Image Criteria:

- Photographs must be submitted in electronic format** (must be a .jpg or .tif or .RAW file.)  
Unfortunately, at this time our volunteers do not have time to scan images printed from film. NO WATERMARKS please.
- Because of the high quality printing process, we can only use hi-resolution files. Image size should be **no smaller** than 10 x 8 inches (pixel dimensions 3000 x 2400). Image resolution should be **300 dpi** or greater. File size should be 1MB or greater. (SHOOT THE PHOTOS ON A HIGHER RESOLUTION SETTING ON YOUR CAMERA. We can always reduce the file, we cannot make it larger without affecting image quality. RAW files are ok. Reduced files downloaded from Facebook or taken through Instagram or other "aps" tend to be too small. Send us the file shot from your device's camera.)
- Please send photos with a landscape orientation. We love seasonal shots (shots that would match up with specific monthly events—like the herring run in March, or snowy scenes for the winter months, fall foliage/harvest scenes for the fall months.) We also love wildlife shots, agriculture in the watershed, and shots of people having fun in the watershed. (We have a soft spot for shots of people having fun in the watershed *at TRWA events* too!)

Deadline for image submission is **August 31, 2020**.
