

# Dawson Basketball Officiating Camp

Dawson Community College - Glendive, Montana

June 21-23, 2019

This basketball officiating camp, sponsored by Dawson Community College, is for current youth league, high school, and college officials and for those looking to get started in officiating high school and college basketball games across Montana, North Dakota, South Dakota, and Wyoming. Participants will officiate high school games and receive valuable evaluation from certified referees in addition to excellent education on officiating topics during daily classroom educational sessions.

Officiating Supervisors and Assignors from the Frontier Conference, Mon-Dak Conference, and North Star Conference will provide evaluation.

Dawson Basketball Officiating Camp is approved through the MHSA and NDHSAA to count as 2 study club credits. Montana educators will be able to receive renewal units.

**Mike Thibodeaux** was a Division I basketball official for 31 years in the SEC, Big 12, Conference USA, Sunbelt,

and Southland Conference. He retired in 2017 after having both hips replaced. He officiated 18 years in the NCAA tournament. He is also the current supervisor of officials for football, basketball, and baseball in the northwest Louisiana area. He retired after 23 years at KCS Railroad and is married with two grown daughters.



**Jeff Risk** was a basketball referee for 42 years. He spent 42 years working high school games, 40 years doing college games, and 8 years of professional games. He currently works as the Mon-Dak Conference Commissioner and Supervisor of officials, as well as Supervisor for the North Star Conference and the NDSHAA State Tournaments.



**Mike Fischer** officiated high school basketball for 32 years and at the college level doing men's and women's games for 12 years. He officiated two NCAA Division I Women's Basketball Tournaments. He also spent 11 years as a Big Sky Conference Men's Basketball Observer. For the past 12 years, he has been the Supervisor of officials for the Frontier Conference and is on staff at several high level officiating teaching camps across the country.
