

ATVBC Policy & Guidelines for the Election of Directors:

1. Bylaw 14 states that there shall be not less than five Directors and not more than fifteen.
2. Each candidate must be a member in good standing of ATVBC prior to the acceptance of the candidate's nomination and at the time of the election. Only one member of the immediate family may be elected as a Director and serve, at any given time.
3. Every candidate, and their nominators, must have reached the full age of eighteen (18) years at the time of the election.
4. A candidate in good standing at the time of the AGM, having duly signed and sent in their nomination papers signed by two members in good standing, may or may not be present at the time of the election.
5. Candidates who are not present and who have submitted a pre-signed nomination form may have a representative speak for them by submitting a signed authorizing letter to the Nominations Committee Chair.
