SCC Young Professional Tandem Full Golf Membership

SCC Young Professional Tandem Full Golf Membership provides unlimited access to all Club facilities and amenities including our **18 hole golf course, driving range, pool and pavilion complex, tennis courts, pickle ball, golf tournaments, as well as all Clubhouse dining, banquet facilities, and all social activities**. In addition, Young Professional Tandem Members **can host and sponsor private events at the Club**.

Young Professional Tandem Full Golf Membership is available to ages 21-39. Membership available for 2 years, after 24 months dues revert to current SCC Tandem Member rates, as long as both Tandems remain Members in the same category.

Young Professional Tandem Full Golf Member Initiation Fee: \$500. (Can be paid in 2 installments)

Monthly Dues: \$158.00

Plus: a monthly capital fund fee of \$40.00 per month for residents or \$24.00 per month for non-residents
Quarterly Food Minimum is \$75.00 for a single person and \$150.00 for a family (2 or more per household)

- Young Professional Tandem Initiation Fee can be paid in 2 installments within the first 6 months.
- YP Full Tandem Golf Memberships are based on 1 golfer. Spouse or SO can add golf at an annual rate.
- Non-Resident Membership is defined as a member who **DOES NOT** maintain a residence within 25 miles of the Club, based on Mapquest's shortest calculated distance.
- Young Professional Tandem Members can Tandem with a current SCC Member or join with a New Tandem Member that are within the same Membership Category.
- Dependent Children (Children age 26 & younger, living at home and claimed on 1040 federal tax form) are included on Membership.
- YP Full Golf Tandem Memberships includes unlimited golf for 1 person. All household family members may utilize with club dining facilities, social events, swimming complex, tennis, pickle ball, driving range.
- Membership Includes: Bag Slot for the first 2 years.
- Additional services available include: Men's and Women's Golf Associations, Handicap System, Golf Pro Shop, lessons for golf, swim and tennis.

SCC Young Professional Tandem Activities Membership provides access to all Club facilities, driving range, pool and pavilion complex, tennis courts, pickle ball, as well as all clubhouse dining, banquet facilities, and all social activities. In addition, Young Professional Tandem Members **can host and sponsor private events at the Club**. Activities Members **can play golf up to 5 times per year on a per diem basis** and **participate in any social golf activities**. Young Professional Tandem Activities Membership is available to ages 21-39. Membership available for 2 years, after 24 months dues revert to current SCC Tandem Member rates, as long as both Tandems remain Members in the same category.

Young Professional Tandem Activities Member Initiation Fee: \$500. (Can be paid in 2 installments)

Monthly Dues: \$105.00

Plus: a monthly capital fund fee of \$40.00 per month for residents or \$24.00 per month for non-residents
Quarterly Food Minimum is \$75.00 for a single person and \$150.00 for a family (2 or more per household)

- YP Tandem Activities Membership includes: All household family members may utilize with club dining facilities, social events, swimming complex, Tennis, Pickle Ball, Driving Range.
