

2025 SCC Swimming Pool Rules

SAFETY & CONSIDERATION RULES

- It is the responsibility of members to know and follow all pool rules.
- All members and guests must sign in at the registration desk before entering the pool. Guests must be accompanied by a member.
- The Club will not assume responsibility for children. Children under the age of 12 must be accompanied by a parent/guardian at all times.
- Proper swim attire is required.
- Children not toilet trained must wear swim diapers.
- Pool restrooms must be used for any clothing changes (ALL ages) and diaper changes.
- All children must pass the swim test **BEFORE** swimming in the deep end of the pool, going down the slide, or off the diving board. Guard has right to limit swim area for swimmer, if they believe swimmer is unable to safely swim in certain pool areas.
- At pool break, only swimmers 16 and over are allowed in the pool. Children, 5 and under, who have not passed their swim test may accompany an adult. All other swimmers must exit the pool and **STAY AWAY FROM THE EDGE OF THE POOL** during break.
- The lap lanes are reserved for adult swimmers when present.
- "Outside" food & drinks are **NOT** allowed when the Club/Pavilion is open. In accordance with our State of Ohio liquor license, "outside" alcoholic beverages are prohibited at all times.
- No Food allowed in the Pool area. Must be kept up on the top level. Glass items are prohibited.
- Members and guests must remain in the pool and pavilion areas. For safety purposes, entering the golf course area behind the pool and pavilion is not allowed.
- No one is allowed in any Clubhouse dining area in a bathing suit. When you go to the Clubhouse and patio, please wear appropriate clothing.
- The guards on duty have the authority to remove anyone due to inappropriate behavior. A decision of a pool manager or guard is final in all matters pertaining to the safety and enjoyment of individuals using the pool.
- Club management, pool manager or designee are authorized to close the pool when necessary for safety, maintenance, or weather reasons.
- The Club assumes no responsibility for the safety of anyone using the pool.
Members and guests must at all times conduct themselves in a manner that will promote the safety and enjoyment for everyone utilizing our facility.

POOL RULES

1. No admittance to the pool area without a lifeguard on duty. Swimming allowed only when lifeguard is on duty. Do not enter pool deck when closed.
2. No child over 5 years of age will be allowed in the baby pool area.
3. No running, pushing, dunking, excessive splashing, throwing, shoulder sitting or standing, excessive horseplay, or inappropriate behavior are allowed in pool and pool areas, including the locker rooms and steps.
4. No bouncing balls on pool deck or walls. No throwing hard balls in pool area, nerf style balls allowed.
5. No diving in the shallow end that are less than 5-feet in depth.
6. No flips or backward dives off pool deck.
7. No hanging on lane ropes, ladders, or handrail.
8. No rafts. Noodles, kick-boards, and flotation aids for children are permitted.
9. No food or snacks of any kind on the pool deck. All food must be eaten up in the Pavilion area.
10. No food, snacks, gum or beverages allowed in the pool.
11. No glass containers, breakable items, or chewing gum are allowed in the pool area.
12. No smoking or vaping within the fenced pool deck area.
13. No person with open sores, skin, eye, ear, or respiratory infections may use the pool.
14. No pets are allowed in the pool area.

SCC 2025 Swimming Pool Rules Continued

SLIDE RULES

1. Only one person on the slide at a time.
2. No foreign objects (goggles, life vests, swimmies, flotation devices, etc.) are allowed.
3. Riders must wait at the bottom of the steps until the guard indicates that they may go up.
4. No stopping and/or climbing back up the slide is allowed.
5. Riders must ride feet first and belly side up to ensure safety.
6. No Swimming or Standing in front of Slides.
7. No Hanging on Slide openings. Stay clear of slide openings at all times.
8. Guards have the authority to deny slide privileges from anyone who disobeys the rules.

DEEP END & DIVING BOARD RULES

1. Only one person on the diving board at a time.
2. Diving board users must exit using a ladder.
3. No goggles or floaties on the diving board.
4. No jumping or diving off the side of the board. Must go off the front of the board.
5. No hanging off or climbing onto the diving board.
6. No handstands or cartwheels, or tumbling off diving board or pool deck.
7. No flips or backward dives off pool deck.
8. No swimming underneath the diving board when diving board is open.
9. No swimming in the deep end when diving board is open.
10. No foreign objects (floats, life vests, swimmies, inflated toys, balls, etc.) in the diving area.
11. If Guard determines a person does not have the skill ability to perform the trick (flip, dive etc), the person needs to abide by that decision and not attempt trick.
12. Guards and pool manager can restrict tricks off the diving board if determined to be unsafe.
13. People using the board and deep end must have the swim ability to swim to the side safely across the deep end of the pool.
14. If the caution cone is on the board for closure, no one is to remove the cone without lifeguard approval.
15. If deep-end games are approved by the Guard on duty, the cone will be on the board, restricting use, during those games.

Guards shall have the discretionary authority to use the following discipline guidelines:

1st offense = Verbal warning.

2nd offense = Sit out of the pool for 10 minutes.

3rd offense = Leave the pool area for the remainder of the day. Parent will be contacted.

4th offense or flagrant abuse of rules = Must meet with Club management with parents.

Note: Lifeguards may ask person to leave the pool area at anytime if they deem necessary.
