## Non-Resident Membership 2023 Pricing Structure

- Non-Resident Member Initiation Fee can be paid in 2 installments within the first 6 months.
- Non-Resident Golf Memberships are based on 1 golfer, see additional prices for more options.
- Non-Resident Membership is defined by member who **DOES NOT** maintain a residence within 25 miles of the club, based by Mapquest's shortest calculated distance.
- Dual Non-Resident Membership is defined by member who maintains a residence within 25 miles of the club, based by Mapquest's shortest calculated distance, as well as, a residence in a locations further than 25 miles of the Club. Dual resident members must be out of town/state at least 6 months and 1 day per year, and provide an affidavit and state ID.
- Out of State Non-Resident Membership is defined by member who maintains a primary residence out of the state of Ohio.
- Dependent Children (Children age 26 & younger, living at home and claimed on 1040 federal tax form) Are Included in Member's Membership at no additional cost.
- All Non-Resident Members (**except Out of State Members**) are charged a \$24.00 **Monthly Capital Fund Fee**, Billed Monthly.
- Non-Resident Social Membership Includes: All Club Dining Facilities, Social Events, Swimming, Tennis, Driving Range, unlimited golf rounds on per diem basis.
- Non-Resident Golf Membership Includes: Unlimited rounds of golf for 1 member, All Club Dining Facilities, Social Events, Swimming, Tennis, Driving Range.
- Optional Items Includes: Lockers, Bag Slots, Men's and Women's Golf Associations, Handicap System, Pro Golf Shop, Lessons for Golf, Swim and Tennis.
- All Members have the privilege of hosting private and business events utilizing the Springfield Country Club Facilities.
