The "Created Equal Initiative" was developed in 1963 by the National Endowment for the Humanities to mark the 150th anniversary of the Emancipation Proclamation. Part of its purpose is to "encourage members of communities to revisit the history of civil rights in America and to reflect on the ideals of freedom and equality that have helped bridge deep racial and cultural divides."

Dr. Wheelock is assistant professor in the English department at George Mason University. He earned his PhD in English from Brown University. He specializes in the study of Atlantic history and culture.

Session 4: The Loving Story (Loving v Virginia, 1967); Landmark Supreme Court decision

Mr. Zener is an OLLI member/instructor who served as a lawyer with the U.S. Department of Justice.

Session 5: "Freedom Summer"

Presenter: Dr. Devon Johnson

Dr. Johnson is an Associate Professor in the Department of Criminology, Law and Society at George Mason University. Her current research is on punishment preferences and police-citizen relations in the U.S. and Caribbean with an emphasis on understanding racial and ethnic differences in public opinion.

Session 6: "Freedom Riders"

Presenter: Joan Trumpauer-Mulholland

Ms. Trumpauer-Mulholland participated in the New Orleans, Louisiana to Jackson, Mississippi Freedom Ride via the Illinois Central Railroad on June 8, 1961. She was a Non-violent Activist Group (NAG) member, studied at Duke University and at Tougaloo College, and was a Freedom Summer organizer in 1964.

Session 7: "Created Equal and the Racial Integration of United States Armed Forces"

Presenter: Alan Gropman

Mr. Gropman is an OLLI member/instructor and author of *The Air Force Integrates*, part of a Smithsonian History of Aviation series.
