

# **Emerging CMO Fund**

A fund to increase the number of excellent charter school networks led by entrepreneurs of color

#### **Program Overview**

The Charter School Growth Fund (CSGF) is looking for the next generation of entrepreneurs from across the country to join the 31 talented leaders of color who have received support through the Emerging CMO Fund to date.

Through the Emerging CMO Fund, CSGF will support the growth of the next cohort of high-performing, early-stage charter school networks led by entrepreneurs of color. This program is available to entrepreneurs of color who currently lead a single-site or an early-stage charter school network that they want to grow into two-to five-school networks.


#### **Key Components**

- CSGF will make grants ranging from \$250,000 to \$500,000 to support costs associated with each organization's growth. Grant recipients have the opportunity to engage in individual and group learning, participate in the annual CSGF Emerging CMO Retreat, and receive mentorship from CEOs who successfully scaled their organizations to become multischool charter school networks.
- Leaders who receive support through
  the Emerging CMO Fund join a cohort
  of entrepreneurs who are leading their
  networks through an early stage of growth.
  Their organizations use a variety of
  educational models and serve students of
  various ages and backgrounds throughout
  the country.

#### SELECTION CRITERIA

Applicants to the Emerging CMO Fund should demonstrate the following:

- Proven Leadership
   A track record of three to five years of demonstrated success in a leadership role of a charter school or early-stage charter school network.
- Academic Performance
   A record of operating schools that outperform their local districts and perform well compared to the average school in their state on state-administered assessments.
- Underserved Students
  A commitment to serving students
  from high-need backgrounds and
  communities that have few highquality public schools.
- Vision for Growth
   A desire to grow a charter school network by adding between one and three schools.

# Online Application

Applicants should submit an online application at submit.chartergrowthfund.org. Please email emergingcmo@chartergrowthfund.org with any questions.

# Data Submission

Applicants will be required to provide the following information: (1) three to five years of state test results; (2) student demographics; (3) three years of audited financial statements; (4) leadership team biographies; (5) charter agreement; and (6) letter of good standing from your charter authorizer. The application portal contains additional information about these requirements.

# Written Response

Applicants will need to answer each of the following questions in 300 words or less.

- **LEADERSHIP** What strengths will you leverage as your organization grows? As a leader, what areas will you need to develop as you embark on a phase of growth?
- GROWTH Why is your charter school organization pursuing growth? What impact do you wish to have in your community?
- CHALLENGES What are 1-3 challenges you expect to encounter as you grow your charter school organization?

Top applicants will be named semi-finalists and undergo a thorough due diligence process. We will learn more about semi-finalist's leaders, academic and organizational models, and potential to scale in spring 2019 and announce finalists in June 2019.

# **About Charter School Growth Fund**

The Charter School Growth Fund is a nonprofit that identifies the country's best public charter schools, funds their expansion, and helps increase their impact. We support a growing portfolio of the nation's leading public charter school networks. This group includes over 60 charter school networks across 28 states that operate more than 870 public charter schools and enroll over 370,000 students. Networks we support typically operate in underserved communities with limited access to high-quality schools. Ninety-two percent of the students our portfolio members serve are students of color, and 81 percent are from low-income families.
