## FAQs

**Q1: Who is eligible to earn additional commissions with this promotion?**

A1: Any LifeWave Member who advances to the rank of Manager (for the first time) during the promotion period is eligible for additional commissions. Additionally, the direct sponsor of someone who rank advances to Manager (for the first time) during the promotional period is also eligible for additional commissions.

**Q2: If a Member rank advanced before the start of the promotional period do they still qualify for the extra bonuses?**

A2: No, only those who rank advance to Manager during the promotion period and those who personally sponsor those who rank advance to manager (for the first time) during the promotion period are eligible for additional commissions.

**Q3: Can a sponsor earn multiple \$50 cash bonuses if more than one of their personally sponsored distributors rank advance to Manager during the promotion period?**

A3: Yes, if a sponsor has multiple personally sponsored Members who advance to the rank of Manager for the first time, they will be eligible for \$50 for each of those new Managers.

**Q4: When can a Member and sponsor expect to receive the additional commissions earned during the promotion period?**

A4: A Member and sponsor can expect to receive the additional commissions earned during the promotion no sooner than 30 days following the close of the promotion.

**Q5: Does the Rank Advancing Member and their sponsor need to remain active for the duration of the promotion and through to the promotion pay date to receive the earned additional commissions?**

**Q6: Does a newly achieved Manager need to maintain the rank of Manager to receive additional commissions?**

A6: No, if you rank advanced to Manager during the promotion, maintaining this new life-time rank as a paid-as rank is not a requirement to receive the additional commissions.
