How and when is BGANZ Council Membership elected?

- BGANZ Council has a maximum 15 positions available – a (minimum of 4 available in 2017.)
- Council members are appointed for two years. (Oct 2017- Oct 2019)
- Council Members are nominated by Regional Groups, or State membership before the BGANZ AGM. **Council is informed prior to the AGM** and nominations are officially appointed at the BGANZ AGM 2017.
- Council Membership has a six-year limit. (Exceptions outlined below)

How do I get elected to Council if I'm a member of a BGANZ Institutional Member?

In short members should contact their Regional Group Chair and/or State or Territory Council Representative ([List](#)) and express interest well ahead of BGANZ AGM, October 2017.

Council Membership

All positions are for 2 years and have a maximum tenure of 6 years unless stated.

- Australia State and Territory: (8 Members)
- New Zealand (2 members):
- Capital City Gardens Australia (2 members)
- Councillor at Large (1 member)
- Immediate Past President (1 member)
- Co-opted Members (1 or 2 positions available, depending on allocations above.)

I am a member of a BGANZ Institutional Member, how can I get elected?

State and Territory Positions Australia: (8 positions)

Each Australian Regional Group, (Victoria, NSW, Queensland) has one Council position elected by the Regional Group members. Where no formal regional group exists, (ACT, Northern Territory, South Australia, Tasmania and West Australia), these positions are ordinarily appointed by BGANZ membership in each State or Territory. Please contact your Regional Group Chair or your State and Territory representative for more information. Regional Groups usually nominate their Council asap in 2017. ***BGANZ Council is informed of the decision ahead of the BGANZ AGM 2017 and nominations are officially appointed at the AGM.***

New Zealand Regional Group: (2 positions)

New Zealand has two Council positions. BGANZ-NZ is funded by the 6 major gardens and the Council representatives are drawn only from those six gardens.

One of two BGANZ Council NZ representatives will also be BGANZ Vice-President New Zealand. ***BGANZ Council are informed of this decision prior to BGANZ October 2017 AGM.***

Capital City Membership (2 Positions):

Capital City Heads of Botanic Gardens (CHABG) has a maximum of two Council positions. The two CHABG positions are selected by CHABG and ***BGANZ is informed of the decision prior to BGANZ AGM 2017.***

Councillor at Large (1 position)

A Councillor-at-Large nominated by the representatives of Associate members and Individual members. Members wishing to nominate for this position please contact secretariat@bganz.org.au

The Immediate Past President. (1 position)

Co-opted Members. (Maximum of 2 positions. If all positions above is occupied then only 1 Co-opted Member position is available.)

Co-opted Members shall be persons invited by the Council to join the Council, with a maximum of two Co-opted Members of Council serving at the one time. Members may ask Council to be nominated for a position prior to the 2017 AGM. Council appoint Co-opted Members. Interested? Contact secretariat@bganz.org.au

10. Governance of the Organisation

- 10.1 A Council conducts the affairs of the Association. The Council must have a maximum of 15 members and comprise:
- (a) One regional representative from each Australian State and Territory nominated by the regional group or groups in those Australian States and Territories in which such groups exist.
 - (b) In any Australian State or Territory where there is no formal regional group, one regional representative nominated by institutional members located in the relevant State or Territory.
 - (c) Two representatives from New Zealand botanic gardens nominated by regional group or groups in New Zealand;
 - (d) A maximum of two members nominated by the Capital-city Gardens.
 - (e) A Councillor- at-Large nominated by the representatives of Associate members and Individual members
 - (f) The Immediate Past President.
- 10.2 The Officers shall be elected by and from the Council members for a term not exceeding two years by the Council members and shall be:
- (a) the President,
 - (b) two Vice-Presidents, one each from Australia and New Zealand,
 - (c) an Officer combining the roles of Secretary/Treasurer.
- 10.3 Co-opted Members shall be persons invited by the Council to join the Council, with a maximum of two Co-opted Members of Council serving at the one time. This number does not include co-opted Office holders appointed under sub-clause 11.2.
- 10.4 The Officers shall constitute the Executive Committee, which shall be entitled to conduct the business of the Association between meetings of the Council.

11. Term of Office

- 11.1 Council members must be elected or appointed for terms of up to two years and if re-elected or re-appointed, will be eligible to serve for a maximum of three consecutive terms.
- 11.2 If a casual vacancy occurs in the Council, the Council may co-opt a person to fill the vacancy and the person so appointed holds office, subject to these rules, until such time as the vacated position has been filled in accordance with sub-clause 10.1.
- 11.3 Co-opted Members may be members of the Council for a term extending from the annual general meeting at or after which they are invited to join the Council until the annual general meeting in the succeeding year, when their term may be extended by the other members of the Council.
